In producing herewith 03 (three) following arrested accused persons namely 1. Bijoy Roy (M/20yrs) S/O- Joynath Roy of Pundibari, near Krishi Viswavidyalaya, P.S-Pundibari, Dist-Cooch-behar, A/P-near Mahananda Bridge, Prakash Nagar, W,No- 43, P.S- Bhaktinagar, Dist-Jalpaiguri, 2. Dhanu Ram (M/22yrs) S/O- Lt Dilip Ram of Ratan lal Busty, Mallaguri, W.No- 01, P.S- Pradhannagar, Dist- Darjeeling 3. Chandan Barman (M/30yrs) S/O- Lt. Sukaru Barman of Tulsi Nagar, Near Maszid, P.S-Matigara, Dist- Darjeeling under arrest along with the following seized articles:-

1. One iron rod measuring about 18 inch" (approx) from the possession of the accused namely Chandan Barman which was kept on his right hand.

2. One iron made knife measuring about 08 inch" inch from the possession of the

accused namely Bijoy Roy which was kept on his right waist.

3. One iron rod measuring about 12 inch" (approx) from the possession of the accused namely Dhanu Ram which was kept on his right hand.

I, PSI Chiranjit Saha of Bhaktinagar PS/SPC would like to lodge this written complaint against the above noted persons and 5/6 others persons to the effect that today i.e on 06.09.2023 while myself along with ASI Chandra Prakash Adhikary, C/374 Debraj Biswas, C/1426 Prasanta Kr. Datta, CV/014 Labanyamay Barman were performing night mobile van duty, at about 00.30 hours received a secret source information that a group of 08/09 persons had assembled at Near Mahananda Bridge, Prakash nagar under Bhaktinagar P.S with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to I/C Bhaktinagar PS over telephone and as per telephonic instruction we rushed to the spot to verify the veracity of the information and to work upon it. This refers to Bhaktinagar PS GDE no-256, dated-06/09/2023. At about 01.05 hours we reached near the spot as directed by the source and stopped at a considerable distance from above noted spot. After few moments later we started walking towards the P.O with due care so that no one could anticipate our movement and found a group of 08/09 persons sitting there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 03(three) above referred accused persons. On interrogation the 03(three) persons disclosed their identity as noted above and confessed that they along 5/6 others had assembled there with a view to commit

dacoity in Prakash Nagar adjacent areas after making full preparation. Thereafter all the apprehended persons were searched in presence of the available witnesses and the following articles were seized. 1. One iron rod measuring about 18 inch" (approx) from the possession of the accused namely Chandan Barman which was kept on his right hand. 2. One iron made knife measuring about 08 inch" inch from the possession of the accused namely Bijoy Roy which was kept on his right waist. 3. One iron rod measuring about 12 inch" (approx) from the possession of the accused namely Dhanu Ram which was kept on his right hand.

All the articles were seized between 01.40 hrs to 02.05 hrs issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested between 02.06 hrs to hrs 02.15 hrs as they had assembled for committing heinous crime.

Under the above circumstances, I pray before you that a specific case U/S 399/402 I.P.C may kindly be started against the 03 (three) persons arrested namely 1. Bijoy Roy (M/20yrs) S/O- Joynath Roy of Pundibari, near Krishi Viswavidyalaya, P.S-Pundibari, Dist-Cooch-behar, A/P-near Mahananda Bridge, Prakash Nagar, W,No-43, P.S- Bhaktinagar, Dist-Jalpaiguri, 2. Dhanu Ram (M/22yrs) S/O- Lt Dilip Ram of Ratan lal Busty, Mallaguri, W.No-01, P.S- Pradhannagar, Dist- Darjeeling 3. Chandan Barman (M/30yrs) S/O- Lt Sukaru Barman of Tulsi Nagar, Near Maszid, P.S-Matigara, Dist- Darjeeling and 5/6 other persons for assembling with deadly weapons with a view to committing dacoity in Prakash Nagar adjacent areas.
