Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Suman Nandi(33yrs) S/O Lt Satyajit Nandi of Tinbatti colony, P.O Bhaktinagh, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 40 (Fourty) bottles of Premium Strong beer( 5000) Haywards (each bottle containing 650 ml.)
2. 06(six) bottles of Mc Dowells No 1, Superior Whisky (each bottle containing 180ml)

I, SI Prāddip Diyali presently attached with NJP PS under your kind control beg to state that on 03/09/23.06 at 18:05 hrs I received a secret source information that one person namely Suman Nandi(33yrs) S/O Lt Satyajit Nandi of Tinbatti colony, P.O Bhaktinagh, P.S- NJP, Dist.- Jalpaiguri, is selling ID liquor illegally at abandoned Tinbatti colony under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No124/23 date: 03.09.2023 and informed the fact to you. As per your kind direction and instruction myself along with C/1044 Hari Kherwar, C/453 Uttam Dey all of NJP PS, SPC left for Tinbatti colony, under New Jalpaiguri PS, Dist.- Jalpaiguri to work out the information in hand. At 18:35 hrs we arrived at the shop of Suman Nandi(33yrs) S/O Lt Satyajit Nandi of Tinbatti colony, P.O Bhaktinagh, P.S- NJP, Dist.- Jalpaiguri and being identified by the source I held raid at the Tinbatti colony where the above noted accused person selling ID Liquior. Accordingly as per the indication of Source I managed to apprehended him. During raid the persons who were taking liquor was able to fled away from the spot. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19:15 hrs to 19:50 hrs on 03.09.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Suman Nandi(33yrs) S/O Lt Satyajit Nandi of Tinbatti colony, P.O Bhaktinagh, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
