With due respect, I Mrs. AKADASHI BISWAS, W/o. Jagadish Biswas, residence of Porajhar, PS: Bhaktinagar, Satellite Township, Dist.: Jalpaiguri, PIN: 734015, want to file an FIR regarding the huge theft case caused in my house.

On 04/09/2023 at 4:30 pm when my younger daughter Miss Payel Biswas returned from school, she noticed that the lock of front door is broken. She called the neighbours and told the situation to them and went inside the house along with neighbours. Then she noticed that someone had broken their trunk and stolen all the jewelry.

The details of the jewelries stolen are: 1 piece of gold locket, 1 piece of gold choker, 1 set of heavy gold earrings and many other silver jewelries like baju, payal, chains etc. The approx. worth of the stolen jewelries amount to be Rs. 80,000/- and some hard cash worth Rs. 15,000/-.

During the incidence, I was at my work place, in the factory. My daughter was at her work office and my son was busy working at a car showroom, and my younger daughter was at school.

I therefore, request your good self to kindly accept my FIR and do the needful to help me get back my above jewelries and cash.
