Sir,

In producing herewith one (01) arrested accused person namely Dilip Barman (34) S/O, Chittaranjan Barman of Fayranay Jote, PS-Ranidanga, PS-Bagdogra, Dist- Darjeeling along with the following articles under proper seizure as per seizure list;

- (i) 30 (Thirty) bottles of "CHLORPHENIRAMINE MALEATE & CODEINE PHOSPHATE SYRUP" cough Syrup, each bottle containing 100 ML, (each bottle containing 10 mg codeine phosphate out of 100 ml) having batch No. TVHB0593, Mfg. Date 05/2022, Expiry date 04/2024 value of Rs. 135/-each bottle, found in a OLIVE COLOUR carry bag, which was hanged in his motorcycle and marked as "Exhibit- A".
- (ii) One bottle of CHLORPHENIRAMINE MALEATE & CODEINE PHOSPHATE SYRUP" cough Syrup, each bottle containing 100 ML, taken as sample for examination and marked as "Exhibit A-1".
- (iii) 01 (one) red color Yamaha ZR Motorcycle bearing Reg. No. WB-74-U- 5961.
- (iv) 01 (one) blue color Honor smart phone having IMEI No. (i) 868102049089829 and IMEI No. (ii) 868102049289825

I, SI Ajen Lepcha S/O Dup Tshering Lepcha of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person namely Dilip Barman (34) S/O, Chittaranjan Barman of Fayranay Jote, PS-Ranidanga, PS-Bagdogra, Dist- Darjeeling to the effect that on 07/09/2023 at about 15:05 hrs I received a specific source input that one person is possessing huge quantity of illegal 'Codeine Phosphate' based drugs without any valid license near B.Ed College ground Shivmandir (Charak Mat) under Matigara PS to sell the same to his designed customers for his illegal gain. Accordingly, the matter was diarized in General Diary vide Matigara PS GDE No 348 Dt. 07/09/2023 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, I along with ASI Pema Dorjee Sherpa, ASI Dharendra Nath Mandal, C/219 Sonatan Chitrakar, CV/643 Animesh Roy all of Matigara PS SPC left for B.Ed College ground Charak Mat, under Matigara PS along with investigation kit by Govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No.349, Dt.07/09/2023 and M.C.C No-943/2023 Date- 07/09/2023.

After reaching near B.Ed College ground (Charak Mat) under Matigara PS I contacted two persons namely (1) Vishal Sarkar (24) S/O Bibhas Sarkar of Rabindraarani, PO-Kadamtala, PS-Matigara, Dist-Darjeeling and (2) Hargobinda Das (24) S/O Prabir Das of Narayanpally, PO-Kadamtala, PS-Matigara Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure be made upon which they agreed. I also called the R.T van officer to come at the spot along with force and called videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Aurobindo Nagar, Ward No 22, PS Siliguri, over his mobile phone (9800325284) to come with his video camera and record the entire process of search and seizure.

Thereafter, being pointed by my source, I with the help of force detained 01 (one) person who was waiting for his customers near B.Ed College ground (Charak Mat) for delivery of narcotic substance. We disclosed our identity and the information in hand and stated him that he will be searched for the purpose in person. Then, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. I also offered the independent witnesses to search our Police Party as per provisions of law but they did not search the police party. In the mean time Van Officer SI Krishna Chandra Mondal C/480 Sujit Sarkar and C/989 Satya Narayan Ghosh along with cameraman named Somnath Chatterjee arrived at the spot.

I then sent ASI Dhirendranath Mandal with a requisition to Special Executive Magistrate, Shri Santanu Tarafdar Assistant Commissioner of Police (Armed Police) detailed for acting as Special Executive Magistrate of SPC for the day requesting him to come to the spot for supervising the process of search and seizure.

Accordingly at 17:05 hrs Shri Santanu Tarafdar Assistant Commissioner of Police (Armed Police) detailed for acting as Special Executive Magistrate of SPC arrived at the spot at B.Ed College ground (Charak Mat) under Matigara PS as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person, following all formalities, keeping his decency and recovered (i) 30 (Thirty) bottles of "CHLORPHENIRAMINE MALEATE & CODEINE PHOSPHATE SYRUP" cough Syrup, each bottle containing 100 ML, (each bottle containing 10 mg codeine phosphate out of 100 ml) having batch No. TVHB0593, Mfg. Date 05/2022, Expiry date 04/2024 value of Rs. 135/-each bottle, found in a OLIVE COLOUR carry bag, which was hanged in his motorcycle and marked as "Exhibit- A". (ii) One bottle of CHLORPHENIRAMINE MALEATE & CODEINE PHOSPHATE SYRUP" cough Syrup, each bottle containing 100 ML, taken as sample for examination and marked as " Exhibit A-1". (iii) 01 (one) red color Yamaha ZR Motorcycle bearing Reg. No. WB-74-U- 5961. (iv) 01 (one) blue color Honor smart phone having IMEI No.(i) 868102049089829 and IMEI No. (ii) 868102049289825 from the exclusive possession of accused Dilip Barman.

On demand in presence of Shri Santanu Tarafdar Assistant Commissioner of Police (Armed Police) detailed for acting as Special Executive Magistrate of SPC the detained person namely Dilip Barman (34) S/O, Chittaranjan Barman of Fayranay Jote, PS-Ranidanga, PS-Bagdogra, Dist- Darjeeling failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs.

During further interrogation he admitted in presence of Shri Santanu Tarafdar Assistant Commissioner of Police (Armed Police) detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that he procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed customer without any valid prescription for his personal gain by illegal means. He also disclosed that he has been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

Thereafter, I seized the recovered (i) 30 (Thirty) bottles of 'CHLORPHENIRAMINE MALEATE & CODEINE PHOSPHATE SYRUP" cough Syrup, each bottle containing 100 ML, (each bottle containing 10 mg codeine phosphate out of 100 ml) having batch No. TVHB0593, Mfg. Date 05/2022, Expiry date 04/2024 value of Rs. 135/- each bottle, found in a OLIVE COLOUR carry bag, which was hanged in his motorcycle and marked as "Exhibit- A".(ii) One bottle of CHLORPHENIRAMINE MALEATE & CODEINE PHOSPHATE SYRUP" cough Syrup, each bottle containing 100 ML, taken as sample for examination and marked as " Exhibit A-1". (iii) 01 (one) red color Yamaha ZR Motorcycle bearing Reg. No. WB-74-U- 5961.(iv) 01 (one) blue color Honor smart phone having IMEI No.(i) 868102049089829 and IMEI No. (ii) 868102049289825 from the conscious possession of above noted accused person namely Dilip Barman (34) S/O, Chittaranjan Barman of Fayranay Jote, PS-Ranidanga, PS-Bagdogra, Dist- Darjeeling under proper seizure list in presence of independent witnesses and Shri Santanu Tarafdar Assistant Commissioner of Police (Armed Police) detailed for acting as Special Executive Magistrate of SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labeled and sealed the seized articles in presence Shri Santanu Tarafdar Assistant Commissioner of Police (Armed Police) detailed for acting as Special Executive Magistrate of SPC and independent witnesses and the accused person namely Dilip Barman. The whole process of seizure was made in between 17:15 hrs to 18:30 hrs on 07/09/2023 and was made under the coverage of videography by the videographer named Somnath Chatterjee S/O Sushil Chatterjee of Aurobindo Nagar, Ward No 22, PS Siliguri.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Dilip Barman is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Dilip Barman (34) S/O, Chittaranjan Barman of Fayranay Jote, PS-Ranidanga, PS-Bagdogra, Dist- Darjeeling after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person Dilip Barman (34) S/O, Chittaranjan Barman of Fayranay Jote, PS-Ranidanga, PS-Bagdogra, Dist- Darjeeling and arrange for its investigation.


