Respected Sir,

In producing herewith one arrested accused person namely Rabi Chakrabarty @ Chhotu (33) S/O Puchan Chakraborty of Mallaguri Ratan Lal Busty, PS. Pradhan Nagar, Dist. Darjeeling with the following articles under proper seizure as per seizure list;

a) One Red coloured School Bag styled as "SAFARI" "Sutra" containing 32 bottles of Chlorpheniramine Maleate & Codeine Phosphate cough Linetus having batch no. PHC22048; Mfg. Date, June 2022, Exp. Date No. Nov. 2023, each bottle containing 100 ml and Prize of each bottle is Rs. 205.31 Seized from the exclusive and conclusive possession of Rabi Chakrabarty @ Chhotu and marked as Exhibit A.

I, SI Abhishek Theengh (32), S/O- Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person namely Rabi Chakrabarty @ Chhotu (33) S/O Puchan Chakraborty of Mallaguri Ratan Lal Busty, PS. Pradhan Nagar, Dist. Darjeeling to the effect that on 06.09.2023 at about 19.30 hrs, I received a specific source input that one person possessing huge quantity of Codeine Phosphate & Chlorpheniramine Maleate Syrup based drugs was standing at Parking lot, near Hotel Heritage under Pradhan Nagar PS to sell the same to his designed local customers. The matter was diarized in Pradhan Nagar PS GDE No.370/23 Dt. 06.09.2023 Subsequently, I informed the matter to you on written and with your prior permission and being directed, myself along with PSI Bandhan Roy, ASI Manoj Kr. Roy, C/762 Mojibul Rahaman, CV-242 Rakesh Mangar, CV- 223 Swapan Chhetri, CV 645 Pankaj Gupta all of Pradhan Nagar PS, SPC, and after being contacted to the Videographer Somnath Chatterjee S/O Sushil Chatterjee of Arubindo Pally, P.O.- Rathkhola, P.S. - Siliguri, Dist. - Darjeeling and with investigation kit left for Parking lot, near Hotel Heritage under Pradhan Nagar PS by Govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No.372/23 Dt. 06.09.2023 and M.C.C No- 2216 Date- 06.09.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

After reaching at Parking lot, near Hotel Heritage under Pradhan Nagar PS at around 19.55 hrs, I requested two persons as independent witness by notice namely (1) Sarban Sahani (M/34) S/O Kardhan Sahani of Sahani Busty, Prakash Nagar, PS. Bhaktinagar, Dist Jalpaiguri and (2) Rahul Kr. Sah (M/23) S/O Subadh Sah of Cooliepara, near Samshan Ghat, W/No. 01, PS. Pradhan Nagar, Dist. Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed and thereafter being pointed by my source detained One (01) person mentioned above who was standing at Parking lot, near Hotel Heritage under Pradhan Nagar PS. He had carried one red coloured Bag under his possession. Thereafter, we disclosed our identity and the information in hand and stated him that he as well as the bags under his possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above.

I also offered the independent witnesses and the accused person to search our Police Party as per provisions but he did not search the police party. Consequently, I informed the matter to you and as per your kind order, I informed to Shri Gyalsen Lepcha, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed Codeine Phosphate & Chlorpheniramine Maleate Syrup illegally and requested him to come at Parking lot, near Hotel Heritage under Pradhan Nagar PS to remain present and to supervise the search and seizure.

Accordingly at 20.25 hrs Shri Gyalsen Lepcha, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Parking lot, near Hotel Heritage under Pradhan Nagar PS as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person following all formalities, keeping their decency and recovered the above noted articles from the exclusive and conscious possession of the accused person namely Rabi Chakrabarty @ Chhotu (33) S/O Puchan Chakraborty of Mallaguri Ratan Lal Busty, PS. Pradhan Nagar, Dist. Darjeeling.

Further, on demand in presence of Shri Gyalsen Lepcha, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC, the detained person namely Rabi Chakrabarty @ Chhotu, on being asked, failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate & Chlorpheniramine Maleate Syrup' beyond the prescribed limit.

Thereafter, I seized One red coloured school bag styled as "SAFARI" "Sutra" containing 32 bottles of Chlorpheniramine Maleate & Codeine Phosphate cough Linetus having batch no. PHC22048; Mfg. Date, June 2022, Exp. Date No. Nov. 2023, each bottle containing 100 ml and Prize of each bottle is Rs. 205.31, from the exclusive and conclusive possession of Rabi Chakrabarty @ Chhotu which was kept inside one Red Coloured Bag at the spot at Parking lot, near Hotel Heritage under Pradhan Nagar PS under proper seizure list in presence of independent witnesses and Shri Gyalsen Lepcha, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Gyalsen Lepcha, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused person namely Rabi Chakrabarty @ Chhotu. The whole process of seizure was made in between 20.45 hrs to 21.40 hrs with the videography.

Being further asked, the apprehended person namely Rabi Chakrabarty @ Chhotu admitted in presence of Shri Gyalsen Lepcha, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that he have procured Chlorpheniramine Maleate & Codeine Phosphate cough Linetus Syrup clandestinely for the purpose of selling the same in high rate to their designed local customers for his personal gain by illegal means.

On further being asked, he also disclosed that he have been dealing in this business of procuring and selling of 'Chlorpheniramine Maleate & Codeine Phosphate cough Linetus Syrup' based drugs illegally for last few months in and around Siliguri and its adjacent areas along with his associates namely Rajesh Chakraborty s/o Puchan Chakraborty of Ratan Lal Busty, PS. Pradhan Nagar, Dist. Darjeeling, Ranjan Sahani s/o Lalu Sahani of Durgaguri, PS Pradhan Nagar, Dist. Darjeeling, Niranjana Roy @ Khao s/o Sree Roy of Durgaguri, Shankar Mahato, s/o Rajendar Mahato of BRI Colony, PS Pradhan Nagar, Dist. Darjeeling, Chandan Sarbhagya of BBD Colony, PS Pradhan NAGAR, Dist. Darjeeling, Pranay Chahar of BBD Colony, PS Pradhan NAGAR, Dist. Darjeeling, Tarun Sarkar of BBD Colony, PS Pradhan NAGAR, Dist. Darjeeling, Munna of Pokajote, PS Pradhan Nagar, Dist. Darjeeling, Liton of Panitanki More over bridge, PS Khoribari, Dist. Darjeeling for their wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Rabi Chakrabarty @ Chhotu is involved in procuring and selling 'Codeine Phosphate & Chlorpheniramine Maleate Syrup' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Rabi Chakrabarty @ Chhotu after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest at 21.42 hrs and subsequently the family members of the arrested accused person has been informed.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Rabi Chakrabarty @ Chhotu (33) S/O Puchan Chakraborty of Mallaguri, Ratan Lal Busty, PS. Pradhan Nagar, Dist. Darjeeling, 2. Rajesh Chakraborty s/o Puchan Chakraborty of Ratan Lal Busty, PS. Pradhan Nagar, Dist. Darjeeling, 3. Ranjan Sahani s/o Lalu Sahani of Durgaguri, PS Pradhan Nagar, Dist. Darjeeling, 4. Niranjana Roy @ Khao s/o Sree Roy of Durgaguri, 5. Shankar Mahato, s/o Rajendar Mahato of BRI Colony, PS Pradhan Nagar, Dist. Darjeeling, 6. Chandan Sarbhagya of BBD Colony, PS Pradhan NAGAR, Dist. Darjeeling, 7.
