In producing herewith two (02) arrested accused persons who disclosed their identities namely 1) Sujit Gupta (50year) S/O Sri Hari Shankar Prasad Gupta of Milan Pally, RBS Club, Ward No. 25, PS- Siliguri, Dist- Darjeeling and 2) Ashish Saha (48year) S/O Hara Chand Saha of Vivekananda Nagar near Babu Sing Sporting Club, Ward No. 42, PS- Bhaktinagar, Dist-Jalpaiguri along with the following seized articles seized under proper seizure list duly attached herewith viz:

- I, SI Ashim Kumar Das of Khalpara TOP-II under PS, Siliguri Police Commissionerate do hereby lodge this written complaint against 1) Sujit Gupta (50year) S/O Sri Hari Shankar Prasad Gupta of Milan Pally, RBS Club, Ward No. 25, PS- Siliguri, Dist- Darjeeling and 2) Ashish Saha (48year) S/O Hara Chand Saha of Vivekananda Nagar near Babu Sing Sporting Club, Ward No. 42, PS- Bhaktinagar, Dist-Jalpaiguri to the effect that on today i.e on 06.09.23 at 16.30 hrs I have received a specific source information that two persons are stock huge quantity cf contraband Cough Syrup in the house of Somarjit Ghosh @ Bhombal rented by Ashish Saha and Sujit Gupta situated at near Morden boys club, Chandra Park under PS Siliguri for sock the same for their wrongful gain. The matter has been diarized vide Khalpara TOP GDE No.147 Dt- 06.09.23. Accordingly I informed the matter to Sri Anupam Majumder, Inspector In-Charge, Siliguri Police Station, SPC and expressed the entire information accordingly and he directed to me to work out the information immediately. Hence at about 16.40 hrs as per his kind direction myself along with SI, Mrinmay Ghosh O/C Khalpara TOP, ASI Inzamamul Haque, ASI Kalachand Singha, ASI Raju Sarkar C/1183 Nikhil Saha C/706 Tapan Debnath, C/717 Hirak Roy, C/736 Subrata Barman, 1703 Suchandan Saha all of Khalpara TOP under Siliguri, Police Station, Siliguri Police Commissionerate left for Jhankar More area to verify the veracity of the information vide M C C. No. 289/23, dt. 06.09.23 which refers to GDE No.148 Dt. 06.09.23 by Govt. Vehicle No. WB 24Y/5978 driven by CV-142/Biswajit Das.

At the time of departure from TOP I took envelope, white paper, sealing wax, gum, seal, weigh machine, Laptop, Printer etc. At about 16.55 hrs we reached at house of Somarjit Ghosh @ Bhombal rented by Ashish Saha and Sujit Gupta situated at near Morden boys club, Chandra Park under PS Siliguri kept our vehicles at a considerable distance. Subsequently we called house owner namely Somarjit Ghosh @ Bhombal and two independent witnesses namely; (1) Vivekananda Singh (58 year) S/O Late Chandrika Singh of Govt. Saw Mill road, Ward No. 04, PS Siliguri, Dist Darjeeling, (2) Sanjay Barman (28 year) S/O Prafulla Barman of Kanchan Bari, Fulbari, PS- New Jalpaiguri, Dist- Jalpaiguri and disclosed our identities and informed them about the information in hand and requested them in writing to accompany us to witness the Police action. They agreed & gave in writing about their consent to accompany Police during the raid.

Then as per source information we entered into the house of Somarjit Ghosh @ Bhombal and as per identification by the source I managed to cordon the house of Somarjit Ghosh @ Bhombal and found that the above noted persons were present their rented house accordingly we detained them. After disclosing our identities, in presence of independent witnesses we had a strong reason to believe that the detained persons were stocking contraband Cough Syrup with tablets in their joint possession for disposing the same at Siliguri area in concealed manner for supplying/ selling the same in Siliguri and its adjacent area for their wrongful gain. On being asked they disclosed their identity as noted above and admitted that they possessed contraband Cough Syrups with tablets. Then I gave them option in written whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Police Officer. They agreed to be searched by anyone of them. Further I served them option notice in accordance with provisions of law in this regard in writing and he also gave his approval of being searched by any one of them in writing on the notice served to them. Then I informed the matter to Sri Rajen Kumar Chhetri Asst. Commissioner of Police, Detective Department, SPC (Executive Magistrate) & I requested him to come at Chandra Park house of Somarjit Ghosh @ Bhombal rented by Ashish Saha and Sujit Gupta situated at near Morden boys club, Chandra Park under PS Siliguri to remain present and supervise the search, seizure and labeling being a Executive Magistrate . Accordingly at 18.30 hrs Sri Rajen Kumar Chhetri Asst. Commissioner of Police, Detective Department, SPC (Executive Magistrate) arrived at the spot and disclosed his identity to the detained persons as well as to the witnesses as a Executive Magistrate. I also offered the independent witnesses and the accused persons to search our Police Party as per provision of law. But they refused to search the police party. Under the supervision of Sri Rajen Kumar Chhetri Asst. Commissioner of Police, Detective Department, SPC (Executive Magistrate) and in presence of two independent and disinterested public witnesses searched the detained persons following all formalities keeping their decency. Then, we searched the rented rooms of Sujit Gupta and Ashish Saha and found that the above seizure articles kept concealed in the said rooms which were not visible from the outside. Then the detained persons confessed that they were in concealed manner for selling/supplying to young boys at siliguri and its adjacent area. On demand in presence of the Sri Rajen Kumar Chhetri Asst. Commissioner of Police, Detective Department, SPC (Executive Magistrate) they failed to produce any valid document in support of possessing of the said contraband Cough Syrup with tablets which was stocking by them.

Accordingly I counted the said Cough Syrup, which was found in the joint possession of the above noted detained persons and found huge quantity cough syrup with tablets. Then, I seized the above noted articles under proper seizure list and labeled, duly signed by the above noted witnesses, Police personnel and the Executive Magistrate Sri Rajen Kumar Chhetri Asst.

Commissioner of Police, Detective Department, SPC and duly acknowledge by the detained persons. I also supplied a copy of seizure list to the detained persons. The whole search, seizure & label were made in between 18.35 hrs and 22.35 hrs. On further asked the apprehended persons confessed in presence of Executive Magistrate Sri Rajen Kumar Chhetri Asst. Commissioner of Police, Detective Department, SPC and other witnesses that they procured the said seized Cough Syrup with tablets for the purpose of illicit gain. On interrogation they disclosed that they had been dealing in such business of selling of said Cough Syrup with tablets illegally since long. Then I arrested the above noted accused persons after observing all guidelines of Apex court.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely 1) Sujit Gupta (50year) S/O Sri Hari Shankar Prasad Gupta of Milan Pally, RBS Club, Ward No. 25, PS- Siliguri, Dist- Darjeeling and 2) Ashish Saha (48year) S/O Hara Chand Saha of Vivekananda Nagar near Babu Sing Sporting Club, Ward No. 42, PS- Bhaktinagar, Dist-Jalpaiguri
