Sir,

In producing herewith one arrested accused person namely Chandana Barman (42yrs) W/o. Chaitu Barman of Farabari, Vijay Colony, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 14 (Fourteen) sealed Bottles of Himalayan Gold 60 up country spirit, each bottle containing 600 ML.

I, SI. PR. Bhutia of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 07.09.2023 at 16:10hrs received a source information from Farabari, under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at her house for selling the same in the customer for her wrongful gain. This refers to Ambari Falakata Out Post GDE No. 237, dated 07.09.23. I informed to O/C Ambari Falakata Out Post about the information. As per his kind instruction I along with (1) ASI. Bhim Bahadur Sunar (2) L/C-741 Mallika Roy both of Ambari-Falakata OP, Under NJP PS/SPC proceed to Farabari under Ambari-Falakata OP to work out the information. At 16:30 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Farabari area and recovered the above noted articles from the possession of accused person namely Chandana Barman (42yrs) W/o. Chaitu Barman of Farabari, Vijay Colony, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in the customer since long for her wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person in presence of witnesses. The seizure was made between 16:35 hrs to 16:42 hrs. Then I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.


