I, ASI Biplab Kumar Das of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Ram Babu Kumar Pandit (M-25) S/o Srl Maheswar Pandit of Lakhnipur Mahesh Patty, P.O & P.S. Ujarpur, Dist. Samastipur, Bihar to the effect that today on 11.09.2023 at 15.05 hrs received a source information that one person has been carrying huge quantity of liquor at Siliguri Junction under Pradhan Nagar Police Station without any valid license and he is waiting for a Bihar bound bus. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with C/762 Majibul Rahaman, CV/223 Swapan Chettri and CV/128 Ajay Kr. Sahani (All of Pradhannagar Ps) had been to Siliguri Junction Bus stand under Pradhan Nagar PS to verify the veracity of source information vide Pradhannagar ps GDE no. 677, Dt. 11.09.2023. On reaching there and as identified by the source found that above noted person was standing at Siliguri Juction Bus stand with a bag in his possession. Subsequently, I along with my force able to detain the above noted person. On being asked the apprehended person disclosed his name and identity as noted above, Further being searched the above noted seized articles were found from his possession. On demand he failed to produce any valid license/papers for carrying of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 01 (One) year-for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Ram Babu Kumar Pandit (M-25) S/o Sri Maheswar Pandit of Lakhnipur Mahesh Patty, P.O & P.S. Ujarpur, Dist. Samastipur, Bihar after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 15.25 hrs to 16.15 hrs at the spot and arrested him after informing the ground of arrest.
