effect that on 12.09.2023 at about 16.15hrs I received a specific source input that one lady is storing said to be ganja at her residential home old Matigara road near Sitla Mandhir Gate Bazar PS Pradhan nagar Dist Darjeeling to sell the

same to her designed local customers.

The matter was diarized in Pradhannagar PS GDE No. 749/23 Dated 12/09/2023 and subsequently, I informed the matter to the inspector In charge, of Pradhan nagar Police Station in written and being directed, I along with SI Gautam Mallik, ASI Manoj Kr Roy, LC/338 Subha Rai, LC/1274 Sushmita Mothey, CV 223 Swapan Chettri, CV 645 Pankaj Gupta, CV 128 Ajay Kumar Sahani of Pradhan nagar PS, SPC along with investigation kit left for the spot i,e old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar Dist Darjeeling by Govt. vehicle bearing no WB74AC9851 to verify the veracity of the information. This refers to Pradhan nagar PS GDE No. 750/23 Dt. 12.09.2023 and M.C.C No- 2166/23 Date- 12/09/2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way to old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar I contacted two persons namely i)Arjun Sarkar (23) S/O Sapan Sarkar of old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar Dist Darjeeling. ii) Om Prakash Paswan (30) S/O Lt Motilal Paswan of old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar Dist Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived at old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar Dist Darjeeling at 17.05hrs and subsequently, being pointed by my source we had been to the house of above noted detained Sabitri Singh.

Thereafter, we disclosed our identity and the information in hand and stated her as well as the house will be searched for the purpose and I gave her option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which she agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the lady accused person to search our Police Party as per provisions. Consequently, I informed the matter to I/C Pradhan nagar PS and as per his kind order, I informed to Shri Manish Kumar Yadav, Assistant Commissioner of Police Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the lady accused suspected to be selling said to be ganja and requested him to come at the spot to remain present and to supervise the search and seizure.

Accordingly at 17.25 hrs Shri Manish Kumar Yadav, Assistant Commissioner of Police Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot and in presence of two independent witnesses, lady police personal searched the above noted detained lady accused Sabitri Singh following all formalities, keeping her decency and recovered the above noted article from exclusive and conscious possession of the lady accused namely 1) Sabitri Singh (45) W/O Satya Narayan Singh of old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar Dist Darjeeling .

It has been found from the multi color nylon bag from above noted Sabitri Singh (45) W/O Satya Narayan Singh of old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar Dist Darjeeling containing 1kg 350 grams said to be ganja.

Further, on demand in presence of Shri Manish Kumar Yadav, Assistant Commissioner of Police SPC. The detained lady namely Sabitri Singh failed to produce any valid documents/papers or explanation for storing and selling of said to be ganja.

Thereafter, I recovered One blue color transparent plastic carry bag containing 1kg 350 grams said to be ganja which is kept in a multi color nylon bag which is marked as exhibit A and seized the same from the exclusive and conscious possession of Sabitri Singh (45) W/O Satya Narayan Singh of old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar Dist Darjeeling under proper seizure list in presence of lady police personal, independent witnesses and Shri Manish Kumar Yadav obtaining their signature and being acknowledged by the lady accused under proper videograph.

Subsequently, I labelled and sealed the seized article in presence of Manish Kumar Yadav, independent witnesses and the lady accused person. The whole process of seizure was made in between 17.30hrs to 17.50hrs.

Being further asked in presence of Shri Manish Kumar Yadv, Lady Police personal and other independent witnesses above noted Sabitri Singh admitted her guilt and stated that she is purchasing the narcotics substance from various sources that she procured the said to be ganja clandestinely for the purpose of selling the same in high rate to her designed local customers for her personal gain by illegal means and also disclosed that she had been dealing in this business of procuring and selling of said to be ganja illegally since long for her wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the lady accused Sabitri Singh directly involved in procuring and selling said to be ganja illegally contravening the norms of NDPS Act.

Therefore, In presence of lady police personal I arrested the above noted lady accused namely 1) Sabitri Singh after observing all formalities and informing the ground of arrest and issued necessary Memo of Arrest and the family member of the arrested person will be informed as earliest.

Under the above circumstances, I am praying to you that a specific case under proper section of law may kindly be started against Sabitri Singh (45) W/O Satya Narayan Singh of old Matigara road near Sitla Mandhir Gate Bazar PS Pradhannagar Dist Darjeeling and arrange for its investigation.
