This is an application u/s. 156(3) Cr.P.C. filed this day by the petitioner duly supported by an affidavit against the persons mentioned in such petition through Ld. Advocate along with vokalatnama and photo copy of some documents for committing offence as stated in the said petition praying for direction upon the OC, Panitanki TOP under Siliguri PS for registering this application as FIR and investigate into the matter.

Perused the said petition.

Heard the Ld. Advocate as well as complainant.

Register the same as Misc. Petition.

On perusal of the facts of the said application and perusal of the documents enclosed by the petitioner in support of his prayer it appears to this Court that information has been tendered to the Commissioner of Police, SPC, Siliguri. On perusal of the petition, it appears that such discloses the commission of cognizable offences and such allegations have been raised on affidavit. At this stage, this Court should not enter into the question of veracity of the allegations but should confine to the question as to whether such allegations discloses a cognizable offence requiring investigation by the police. It would appear that commission of cognizable offences has been spelt out by the petitioner. Hence, the allegations requires a complete and through investigation by the police. Hence, the prayer u/s 156 (3) of CrPC stands allowed. The OC, Panitanki TOP under Siliguri PS is directed to register the petition as a FIR and to cause an investigation into the matter. A compliance report be sent to this Court on or within the next date fixed. If a specific case has already been started over the allegations, the OC Panitanki TOP shall inform such to this Court without registering another I'IR on the same incident.

The complainant above named begs to state as follows:-

- 1. That the complainant along with his mother Bimala Bala Ghosh (since deceased), his one of the sister-in-law Smt. Sikha Ghosh and his three brothers i.e. the accused no. 2, 3 and 4 and another Sister-in-law i.e. the accused no. 1 and others being the co-owners of a G+3 storied building popularly known as 'Air View Hotel' situated at Hill Cart Road, Siliguri out of some temporary family settlement, the complainant along with his deceased mother and the accused persons have decided to enter into a tenancy agreement with the accused no.1 for running a bar cum restaurant business under the name and style "M/s. Madira Bar Cum Restaurant" in respect of a space measuring about 2333 sq. ft. situated in the ground floor of the said G+3 storied building.
- 2. That the complainant and the accused persons and the deceased mother of the complainant have entered into a memorandum of tenancy on 05.07.2014 for running the said business and getting the necessary permission of License from the Excise Department and the accused no.1 has started to run the said Bar cum Restaurant business being License No. 178-2/SLG/98-99 accordingly.

- Characteristics. That the accused no.1 in connivance with the accused no. 2, 3 & Notice and India the forged the signature of my mother for preparing an Siliqui. Dist Darjeeling agreement on 01.11.2021 in respect of a space measuring about 2700 sq. ft. on the rooftop of a G+5 Storied building popularly known as 'Air View Lodge' which is situated just adjacent to the said Air View Hotel and both the said valuable immovable property are the joint undivided properties and the said agreement dated 01.11.2021 which notarized was and authenticated before the Notary Public at Siliguri.
 - 4. That apart from that the accused persons have also forged the signature of mother of the complainant in an affidavit dated

16.12.2021 which was notarized and authenticated before the Notary Public at Siliguri.

- 5. That apart from that the accused persons have also forged the signature of the mother of the complainant in a rent receipt dated 05.12.2021.
- 6. That apart from that the accused persons have also forged the signature of the mother of the complainant in a building sketch map for the said extension of business and which was approved by the Excise Department, Darjeeling.
 - That the accused persons have forged the signature of the mother of the complainant and manufactured those documents as stated above for extending the said Bar and Restaurant business on the rooftop of said G+5 storied building known as Air View Lodge building keeping the complainant in dark.
- 8. That after manufacturing those purported documents, the accused persons have submitted the same to the Superintendent of Excise, Darjeeling and other government offices for obtaining the necessary permission of extension in respect of the said Bar cum Restaurant business on the rooftop of said G+5 storied building.

That on the basis of the said purported documents the accused persons have somehow managed the concerned department for obtaining the necessary permission for extension of the said Bar cum Restaurant business.

reinted by Govi. of India Siliguri Distribution That since the month of January, 2020 the mother of the complainant was seriously ill and she-was in a bed ridden condition due to various old age-ailments and she was not in a position to move and walk alone and her-signature bears in the said purported documents not at all her genuine signature and due to her such serious illness she was also not in a position to appear before the notary public at Siliguri for subscribing her signature in the said purported agreement of tenancy dated 01.11.2021, affidavit dated 16.12.2021 and at the relevant time the mother of the complainant was in a unconscious state of mind to subscribe her signature in those purported documents and physically appear before the Notary Public at Siliguri on

- 11. That beyond the knowledge of the complainant, those documents were manufactured for the specific ulterior motive of the accused persons.
- 12. That the mother of the complainant died on 09.11.2022 at the age of her 85 years.
- That the complainant came to know that the above mentioned practice of fraud of the accused persons when the complainant received the notice from the Court of the Ld. Civil Judge Junior Division at Siliguri in connection with T.S. No. 174/2023 and 184/2023 which are filed by the accused no. 1 in connivance with the accused no. 2, 3 & 4 and they relied those documents as genuine one knowingfully well that they have manufactured those documents by forging the signature of the mother of the complainant and copy of those documents were handedover to the complainant on 23.08.2023 in the usual course of hearing of the above mentioned suits.
 - 14. That the accused persons have purposefully and with the specific motive with the common intention, they forged the signature of the mother of the complainant and manufactured the above mentioned documents and fraudulently used those documents by submitting to the government office and court of law as genuine which they know that those documents are forged and manufactured documents.

Appeinted of Government of the Shiguri Sist. Oscileting O.C. Panitanki T.O.P. on 27.08.2023 but the concerned duty officer refused to receive the said complaint and thereafter the complainant lodged a complaint to the Commissioner of Police, Siliguri Police Commissionerate on 28.08.2023 but till this day no action has been taken by the concerned police authority against the accused persons.

That the accused persons are the habitual offender in regard to the forging of signature and previously the accused no. 2, 3 & antoher forged the signature of the complainant for removing the complainant from the directorship of a company and on the basis of the complaint of the complainant one case has been started being Siliguri P.S. Case No. 364/2022 dated 14.04.2022, U/S -420/465/467/468/471/120B of I.P.C. against the accused no. 2,
