With due respect and humble submission, I PSI Koushik Raha, S/O- Jitendra Raha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodge this written complain after producing herewith the above noted seized articles to the effect that on 13.09.23 at 14.25 hrs while performing PS mobile van duty received a source information that one lady namely Devi Rana was selling liquor in her house situated at Promod Nagar under Bhaktinagar PS/SPC, for her wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No- 655, dated 13.09.23. As per your kind instruction myself along with ASI Chandra Prakash Adhikary, ASI Dipak Karmakar, C/374 Debraj Biswas, LC/1228 Sushila Roy, LCVF 1060 Goma Bhandari proceeded to the PO to work out the information. we reached at the spot, sometimes after, being identified by the source our police party held raid at the house of the above noted accused person and as per my direction LC/1228 Sushila Roy and LCVF 1060 Goma Bhandari able to detain one lady maintaining all decency, who disclosed her identity as noted above. On being searched the above noted bottles of liquor recovered from her house. Further, being asked she confessed that she is doing the business of selling and storing liquor in her house since long for her wrongful gain without any valid documents/license. Then, in presence of available witnesses I seized the above noted articles from the PO after prepared proper seizure list. (The seizure was made in between 15.45hrs to 16.15 hrs). As she has violated the rules and norms of Bengal Excise Act.
