As we interrogated them we found that the girl was from Samastipur District Bihar and the boy was from Vaishali district, according their statement both of them going back to Bihar, as girl came to Siliguri to meet the boy here in siliguri without informing her guardian, because the boy works in a tharmocFactory at Fulbari, Jalpaiguri since 5 years and they met through face book since 1 year. We tried to contact her guardian in Bihar but failed to get connected with them. Then after viewing this we came to the point of her safety and protection for the best of child interest, We communicate to CWC siliguri member Mr Tapas Karmakar over the mobile as per his verbal order, We are here lodging the GDE at your station for further process.
