Sir,  
In producing herewith one arrested accused person named Dinesh Sahani (43 yrs) S/O Late Rajendra Sahani of Coolipara, Ward No 01, PS- Pradhan Nagar, Dist.- Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

Eleven (11) bottles of TUBORG STRONG PREMIUM BEER, each bottle containing 650 ml, each bottle MRP-135 rupees (Total 7.15 liter). marked as exhibit A (Out of which one has been taken as sample for examination marked as exhibit A1)

I, ASI Manoj Kr. Roy of Pradhan Police Station, SPC would like to lodge this written complaint against one accused person named Dinesh Sahani (43 yrs) S/O Late Rajendra Sahani of Coolipara, Ward No 01, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that today on 13.09.2023 at 17.55 hrs received a source information that one person named Dinesh Sahani of Cooli Para is selling illegal liquor at his hotel situated at Regulated Market under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and diarised the matter in General Diary vide Pradhan Nagar PS GDE No 815 dated 13.09.23 and as per his kind direction myself along with C/762 Majibul Rahaman, CV/646 Baban Das ( All of Pradhannagar Ps) had been to Regulated Market under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that above noted person has been selling illegal liquor at his hotel situated at Regulated Market. Subsequently, I along with my force able to detain the above noted person. On being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted seized articles were recovered at his shop which he kept conceal in a water drum. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Accordingly, I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Dinesh Sahani (43 yrs) S/O Late Rajendra Sahani of Coolipara, Ward No 01, PS- Pradhan Nagar, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 18.25 hrs to 18.50 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Dinesh Sahani (43 yrs) S/O Late Rajendra Sahani of Coolipara, Ward No 01, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
