Subject: Complaint against Shri Debashish Dutta, Ranjan and about 40 unknown persons

Dear Sir,

I, Raja Ghosh S/o Late Lakhikanto Ghosh, aged 47 years, resident of Gomustapara, Jalpaiguri, am working with Eyeon Security Service as security incharge and today 10/09/2023 I was on duty in the night shift at Amrit Vyapar private limited site at Chobhabhita, PO Fulbari Hat, under PS NJP, in the district of Jalpaiguri.

Today at around 8:25 PM, my security personal, Suman Chanda, on duty at gate no 5 of Jorapani IP, informed me that around 40 miscreants have assembeled outside, near gate number 6 of Jorapani IP, in 2 wheeler and one Mahindra Ambulance and he appreahended danger.

After few minutes they entered inside Bhai Bhai Food Product gate and started abusing me and my collegues in filthy languages. Their face was covered. They shut down the lights and cctv cameras of Bhai Bhai Food Products premises. Sri Debashish Dutta was instructing the miscreants over mobile to do the above and then to break the boundary of Amrit Vyapaar Private Limited. They were equiped with Lathi, Bhujali and arms. They trespassed the boundary and started assulting me and my collegues. They snatched our torchlight and cash. They directed us to leave the premises immediately and started throwing stones and bolders upon us. We came about 100 ft back from our post for our safety. They broke our tables, chairs and umbrellas. One JCB also enetered in the premises and started breaking the pillars of our boundary. They had also brought one Hydra which was standing outside the gate.

I immediately informed the entire incident in the group and Police came and then we were rescued. Under the above circumstances I request you to take necessary actions as per law.
