Sir,

With due respect I, Sri Swapan Ghosh, S/o Late Mrityunjay Ghosh, Resident of Deshbhandu Para near Indoor Stadium (opp. Of Gouriyo Moth), S.M.C. ward no. 29, P.O. Siliguri Town, Pin- 734004, Dist. Darjeeling let you inform that my mother-in-law Smt. Savita Mondal, Wife of Sri Rabindra Nath Mondal had been to Kalyan Medical Store, Deshbhandu Para, Siliguri along with my son viz. Priyadarshi Ghosh at about 1.30 p.m. on 20.08.2023 for her Check-up/ examination by Dr. Goutam Purkastya there and after examining her Dr. Goutam Purkastya given a prescription mentioning normal saline (NSC), IV Set, Gel Co, Easy fix, Pantodac Injunction and Ondem Injunction which were purchased from the said Medicine shop namely Kalyan Medical Store when Kanchan Chakraborty, his uncle Madhusudhan Chakraborty and his staffs namely Sourav Saha, Rohan and two others were present. They handed over a kaccha Bill for Rs. 1,382.00 (Rupees One Thousand Three Hundred Eight Hundred and Two) only to my son and my son paid the amount to Kanchan Chakraborty online.

After return to home my son handed over the Bill of the medicines to me and it was ascertained that the Bill is exorbitant(more than double). As such, I went to the said medicine shop and produced the Bill to Kanchan Chakraborty saying that he has taken more than double price of the medicines etc. purchased from his shop and requested for refund of the excess amount. Then, said Kanchan Chakraborty asked me to come to the inside room of the medicine shop and accordingly I went in the said room. Then he along with his staffs and one of his some friend started beating me with a buttum on my mouth, my shoulder and different parts of my body saying that they shall kill me. Due to such brutal assault upon me by them, my two teeth, left side collar bone were broken and profused bleeding was happened due to such brutal attack by those miscreants. At that time the Ex-Counselor of Ward No.30 was passing to the front side road who witnessed the occurrence and asked the miscreants to refrain from such illegal act repeatedly when they refrained themselves to assault me and I could escape myself from death. Unless the said Ex-Counselor be not present there and refrained them to assault me they must have murdered me.

My son was nearby the said shop and hearing my cry, my son came to the medical shop and took me from there to our home and then I was taken to Adhya Dental Clinic, Siliguri for examination and treatment and after examining me he stitched the gum where from the teeth were broken and prescribed medicines. The said Doctor advised me to go to orthopedic doctor for immediate treatment of broken collar bone. Then I was taken to Basu clinic where Doctor present there




examined and immediately X-Ray of Collar Bone as well as Chest was done and it was found/detected that my left side Collar Bone was badly Broken/fractured. Therefrom I was taken to my house and sometimes later I became unconscious. On the very next day I was taken to my hometown Arambagh, at Kolkata and then was taken to Apex Nursing Home where I was admitted to the said nursing home and thoroughly examined and immediately they conducted my operation and inserted plate and screw and I was admitted therein from 22.08.2023 to 24.08.2023. After release from the said nursing home I was totally under bed rest therefrom and after quite recovery I have returned back to Siliguri two days back.

I fervently request your goodself to arrest the above named accused persons immediately and to prosecute them according to law keeping them in iron bar.

Since, I am still sick, infirm and cannot move properly, I could not lodge this compliant to your end prior to this.

This is for your kind information and immediate necessary action please.
