Sub : Missing application of my wife Mrs. Kumari Neha Kumar & my son Master Shrawan Kumar

Sir,
I the undersigned would like to inform you that I alongwith my wife, son and father resides at a flat on sent of C/O Mr. Surendra Prasad, Opp. Main Gate Iskon Mandir, Iskon Road, Siliguri - 734001.

Around 25 (Twenty five) days, we were having some family problems and had exchange of hot talks. 3 (three) days ago on September 11, 2023, my wife Mrs. Kumari Neha Kumar packed her clothes and other belongings including gold and cash and was about to leave the residence. I and my father tried to settle the issue and she held back from her decision of leaving the residence.

Yesterday, I had to travel to Begusarai for a business purpose and left residence around 2:20pm. My father Mr. Bipin Kumar had a business meeting at Hotel Sadija, Hill Cart Road Siliguri and left residence around 6:30pm.

Around 8:30pm my father returned from the meeting and found the main door locked. He tried to seek for my wife and son in the nearby locations where she used to go but could not find any trace of my wife and son. Then he broke the lock of the main gate with the help of a lock breaking person and entered the room. He found that no one was inside and 4 (four) trolley were missing. My wife took lanson and all her belongings in 4 (four) trolleys and left. She also carried gold worth rupees 12 (twelve) lakhs and cash around 75000/- (Rupees Seventy five thousand) only. Some 1.50 lakhs was available in her bank account too.

At night my father alongwith some well wishers visited the Police Station but could not file the missing dairy as he was not carrying hand copy photographs of my wife and son.

I returned back today morning around 8:00 AM and read the situation.

Therefore, its my heartfelt request to your office to take immediate action to find my wife and son. I enclose herewith 2 (two) separate missing form fully filled with all details along with the photograph of my wife and son.
