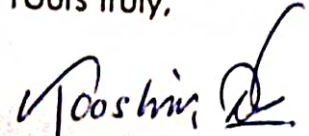
1. That after the demise of my father I along with my widow mother and sister are the joint owner of the below schedules property left by my father.

Our Land Details: MOUZA – KALKUT - DAG / LR PLOT No. 499 / KHATIAN No.40/3 / Land 0.1100 Acres – Name of Raiyat : Kali Pada Dutta, S/O M.N, Dutta.

2. That some land mafias by way of fraud and forgery has prepared some forged documents in connivance with BL & RO – Matigara to grab our land by using muscle power and being aware of the same fact while we were contemplating for taking action against the land mafias namely Sri Bubai Bose, S/O Manoj Bose, Sri Shankar Prasad Ray, S/O Shyam Prasad Ray & Sri Upendra Kumar Ray, S/O Hulash Ray, Sri Anit Kumar Singh, S/O Om Prakash Singh (EMPLOYEE OF SDO OFFICE – SILIGURI, DESIGNATED AS UDC) , Smt. Sushila Singh, W/O Om Prakash Singh (MOTHER OF SRI ANIT KUMAR SINGH- EMPLOYEE OF SDO OFFICE – SILIGURI, DESIGNATED AS UDC), all of them mentioned residing in Narmadabagan, Champasari, P.S- Pradhan Nagar, Dist – Darjeeling & Virju Paswan, S/O Sri Ram Prakash Paswan residing in Kalkut, Champasari, P.S- Pradhan Nagar, Dist – Darjeeling and their associates I came in contact with Jaydeep Debnath, S/O Ranjit Debnath (bearing Aadhaar No. 8311 1865 5662) and Prasanna Kumar Mishra, S/O Yaggi Mishra (bearing Aadhaar No. 5371 4062 8675, both resident of Champasari, P.O – Champasari, P.S – Pradhan Nagar, Dist – Darjeeling who disclosed their identity as honest persons and having knowledge to do the needful for cancelling the fraud khatians and documents and accordingly being induced by the said culprits Jaydeep Debnath and Prasanna Kumar Mishra I entrusted the said persons and at the time of entrustment they demanded Rupees Twelve Lakhs and out of that they have taken advance of One Lakh Twenty Thousand with the assurance that within THREE MONTHS they would complete the entire process for cancelling those fraud khatians and documents and at that time they will receive the balance amount from me. But unfortunately later on I realised that they are the cheat persons while I noticed that they did nothing and as such I demanded for the money which I had made advance to them and accordingly they assured me to return back the said amount within May 2022 but despite assurance they did not return back my money and as such I am lodging FIR against the above noted persons for committing the offence of cheating, fraud and Criminal breach of trust and thus I request to start specific criminal case against the above noted persons and arrest them immediately.
