In producing herewith 05 (five) arrested accused persons namely (i) Kamakhya Majumdar (36 yrs) S/O Late Gopal Majumdar of 2/6, Bagha Jatin Colony, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Anjoy Sarkar (22 yrs) S/O Suranjan Sarkar of Dharam Nagar, Coolipara, PS- Pradhan Nagar, Dist.- Darjeeling (iii) Biswajit Das (26 yrs) S/O Jiban Das of Samar Nagar near Purana Kalibari, PS- Pradhan Nagar, Dist.- Darjeeling (iv) Suraj Mandal @ Bholta (26 yrs) S/O Late Ganesh Mandal of Mahakal Pally, Ward No-44, PS-Bhaktinagar, Dist.- Jalpaiguri, and (v) Abhijit Sarkar (19 yrs) S/O Ratan Sarkar of Bidyachakra Colony, Ward No-44, PS- Bhaktinagar, Dist.- Jalpaiguri along with following seized articles viz:-

I, SI Goutam Mallik of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 05 (five) arrested accused persons namely (i) Kamakhya Majumdar (36 yrs) S/O Late Gopal Majumdar of 2/6, Bagha Jatin Colony, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Anjoy Sarkar (22 yrs) S/O Suranjan Sarkar of Dharam Nagar, Coolipara, PS- Pradhan Nagar, Dist.- Darjeeling (iii) Biswajit Das (26 yrs) S/O Jiban Das of Samar Nagar near Purana Kalibari, PS- Pradhan Nagar, Dist. Darjeeling (iv) Suraj Mandal @ Bholta (26 yrs) S/O Late Ganesh Mandal of Mahakal Pally, Ward No-44, PS-Bhaktinagar, Dist.- Jalpaiguri, and (v) Abhijit Sarkar (19 yrs) S/O Ratan Sarkar of Bidyachakra Colony, Ward No-44, PS- Bhaktinagar, Dist.- Jalpaiguri and 6/7 others to the effect that today on 22/09/2023 at 00:05 hrs received a specific source information that 10/12 miscreants have assembled at Mahananda river bed near near Parbati Ghat under PS- Pradhan Nagar, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Bhagha Jatin Colony area. Accordinghly, I informed the matter to the I/C, Pradhan Nagar PS and diarised the fact in General diary vide Pradhan Nagar PS GDE No 1366 dated 22.09.23 and as per order myself along with SI Youel Lepcha, ASI Monoj Kr Roy, C/762 Mojibul Rahaman, CV/645 Pankaj Gupta, CV/223 Swapan Chhetri CV/128 Ajoy Kumar Sahani, CV/992 Jagadish Biswas, CV/646 Baban Das, CV/242 Rakesh Monger all of Pradhan Nagar PS, SPC, left for Mahandnda River Bed near Parbati Ghat to work out the information in hand. At about 00.25 hrs we arrived at near Parbati Ghat and as indicated by the source we noticed that 10/12 persons assembled at Mahanda river Bed near Parbati Ghat and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 05 (five) of them with deadly weapons in their possession but 06/07 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their associates were assembled there and making preparation for committing dacoity in a house of Bagha Jatin Colony area. On search the above noted weapon of offence recovered from their possession.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Pradhan Nagar PS. The search seizure and arrest made on 22.09.23 in between 01.05 hrs and 02.05 hrs.
