In producing herewith the 01 (One) arrested accused person named Rafikul Haque (47), S/o- Lt. Ajijar on of hummagach PO- Nabugach PC- Paigani Diet Jalasiana named Rafikul Haque (47), S/o- Lt. Ajijar Rahaman of Jummagach, PO- Nakugach, PS- Rajganj, Dist- Jalpaiguri along with the following seized articles under

One Plastic Packet containing 300 (three hundred) grams suspected to be Brown Sugar. (i) One Hero Extreme Motor Cycle Bearing registration No.-WB 74 AP/9863. (ii) (iii)

I, SI Shib Sankar Das, S/o- Nirmal Das of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 01 (One) arrested accused person to the effect that today 25.09.2023 at about 15.25 hrs, I received a specific source input that one person coming from Fulbari side via Gora More and will proceed towards NJP side with one motor cycle bearing registration No.- WB 74 AP/9863 with huge consignment of suspected to be Brown Sugar for his clandestine disposal. The matter was diarized vide NJP PS PS GDE No. 1183, Dt. 25.09.23 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station, Siliguri Police Commissionerate and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Khagen Barman, ASI Dhruba Mishra. C/1044 Hari Kherwar all of NJP PS, Siliguri Police Commissionerate being headed by me left for Gora More, under New Jalpaiguri PS, Dist.- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 1184, Dated- 25.09.2023 and M.C.C. No. 680/23, Dated- 25.09.2023. I also informed the Videographer namely Tapan Mandal, S/o- Tusto Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Gora More, under New Jalpaiguri PS. Dist.- Jalpaiguri to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 15.50 hrs we arrived at Gora More, under New Jalpaiguri PS, Dist. Jalpaiguri. After reaching at the spot, I called two independent witnesses namely (i) Shri Gautam Das, S/o- Lt. Rash Mohan Das of Gora More, Nowapara, PS- NJP, Dist.- Jalpaiguri and (ii) Shri Kartik Bose, S/o- Lt. Swapan Bose of Barivasha, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as independent witnesses under relevant provision of law. After arrival at the spot we are waiting for the target. At about 16.55 hrs, identified by the source, we saw that one person coming from Sahudangi side towards Gora More in a motor cycle bearing registration No.-WB 74 AP/9863. Accordingly, we intercepted the vehicle and apprehended the rider of the vehicle who disclosed his identity as noted above.

After disclosing our identity, we detained the above noted person with a strong reason to believe that he illegally possessing suspected to be Brown Sugar for clandestine disposal the same to NIP area for his wrongful gain. On being asked he confessed his guilt and admitted that he purchased the suspected to be Brown Sugar from 1) Tajmal Haque, S/o- Lt. Bahauddin, 2) Jamal Haque, S/o- Tajmal Haque, 3) Mamuni Khati, W/o- Mujaffar Ali and 4) Md. Israel, S/o- Khaitu Md all of Narayanjote, PS- Rajganj, Dist- Jalpaiguri for his illegal gain. I, then gave him option in writing whether he wanted to be searched in presence of Executive Magistrate or by any Police Gazetted Officer. The apprehended person agreed to be searched by Police Gazzeted Officer. I also offered the apprehended person to search our Police Party as per provision of law but he denied to search police party. Accordingly, I informed the matter to the Officer-In-Charge, NJP PS and as per his kind order, I informed the fact to Shri Passang Topgey Bhutia, WBPS, Assistant Commissioner of Police, Traffic (East), SPC in writing who was detailed for acting as Special Executive Magistrate of SPC for the day regarding the information and necessary action and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly, at 17.25 Shri Passang Topgey Bhutia, WBPS. Assistant Commissioner of Police, Traffic (East), SPC arrived at the spot and accordingly. I disclosed his identity to the detained person as Special Executive Magistrate of Siliguri Police Commissionerate. Then In presence of Shri Passang Topgey Bhutia, WBPS and two independent public witnesses we searched the detained person and found one plastic packet containing suspected to be Brown Sugar which was in his right pocket of his pant. On demand in presence of the Special Executive Magistrate, he failed to produce any valid document in support of possessing of the suspect to be Brown Sugar which he was carrying. After weighing, it was found that the plastic packet containing 300 (three hundred) grams suspected to be Brown Sugar. Accordingly I seized the plastic packet containing suspected to be Brown Sugar, the said motor cycle and one mobile phone which was found from the possession of the detained person. Then I sealed the plastic packet in an envelope, labeled the same and marked as Exhibit-'A'. The whole process of seizure was made in between 17.35 hrs to 18.00 hrs.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Rafikul Haque (47), S/o- Lt. Ajijar Rahaman of Jummagach, PO- Nakugach, PS- Rajganj, Dist- Jalpaiguri (Not verified) is involved in procuring and selling of Brown Sugar illegally and contravening the norms of NDPS Act was established. Then, I arrested the above noted accused person after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the arrested accused person named Rafikul Haque (47), S/o- Lt. Ajijar Rahaman of Jummagach, PO- Nakugach, PS- Rajganj, Dist- Jalpaiguri (Not verified) and others as noted above and arrange for its investigation.
