With due respect I, Kartik Sarkar, S/O – Late Suklal Sarkar, of 9 No-Colony, Ambari Falakata, P.O. – Kamarvita, P.S. – NJP, District- Jalpaiguri, Pin-is situated at Ambari Falakata, near Post Officemore.

It is pertinent to mention here that in my aforesaid shop there are 4 staffs who regularly help to serve my shop and on 21/09/2023 at about 3.25pm one local customer namely Namely Ramu Dhar, S/o – Badal Dhar, of Business Colony, near Chintamohan High School, P.O. – Kamarvita, P.S. – NJP, District- Jalpaiguri, Pin- 735135, came to my shop with a four wheeler vehicle and sitting on a four wheeler, he asked my staff order my said staff has delivered the same to him at his Maruti Car where he was sitting on the road.

It is to be noted here that the biil amount for the aforesaid product was Rs.130/- and said Ramu Dhar gave my staff only Rs.120/- and my staff Swapan Saha requested him to pay the full amount but Ramu Dhar was not willing to pay the full amount and he same then Ramu gave another Rs. 20/- Note to my staff and when my staff insist to pay the him to return extra Rs.10/- change, then said Ramu warned my staff that he would come after a while to teach him and after a while at about 3.29pm said Ramu Dhar again came to my shop with a rush and directly entered into my shop near my cash counter where pressed the neck of Swapan Saha was sitting and without any reason, all on a sudden, he forcibly Swapan Saha mercilessly, Ramu Dhar slapped, kicked and threatened my staff and at the to take my said staff to an another place to kill him and subsequently Swapan Saha was taken to Hospital.

And at the time of incident I was opposite side of my said shop and seeing the incident I came there and tried to stop said Ramu Dhar and requested him not to do such type of behavior but at that time also he was furious and he threatened me with a dire

On previous occasions and on several times, said Ramu Dhar used to take some product from my shop and always tried to pay less amount of money than the actual product value amount and on query I came to know that there are more than 25 shopkeepers have the same allegations against Ramu Dhar and as my staff insist to pay the full bill amount, he take it on sentiments and it is his personal problem.

It is pertinent to mention here that said Ramu Dhar is a Political figure and has a great political hold and as such he never treat us as a human being and as he is a dangerous person and he can do each everything to ruin our lives as well as our business and he has done the said incident with his full motive and with a planned manner in front of several peoples, customers and under CCTV camera and the whole incident is captured by our CCTV camera and I am ready to provide my DVR if it is seized for the sake of investigation process.

Therefore, I am requesting you to enquire into the matter neutrally and punish said Ramu Dhar as per law of the land and I have full respect towards the law and on the other hand said Ramu dhar also threatened us that we could do nothing though he has assaulted my staff under CCTV camera and from this word it can be presumed how do the
