Sir

In producing herewith following three (03) arrested accused persons namely i) Md Aslam @ Munna (19) S/O Md Imtiaz of Khayrowa Jitpur, PS Chhauradanu Dist Motihari Bihar. A/P Samar Nagar Battola near Netaji Mart PS Pradhannagar Dist Darjeeling. ii) Bijay Sahani (26) @Chhotu S/O Devendra Sahani of Maharaj Colony Ward no 04 PS Siliguri Dist Darjeeling. iii) Dilip Biswakarma (40) S/O It Balaram Biswakarma of Gurung Busty PS Pradhan nagar Dist Darjeeling along with following seized articles viz:

- 1) One iron made sharp cutting knife and one iron rod (sabol) recovered from the exclusive possession of accused Md Aslam @ Munna.
- 2) One iron made 'Knife' and one torch light recovered from the exclusive possession of accused Bijay Sahani.
- 3) One iron made weapon called as 'Bhojali' recovered from the exclusive possession of accused Dilip Biswakarma.

I, SI Youel lepcha (28) S/O Jai Tshering lepcha of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 03 (three) arrested accused persons namely i) Md Aslam @ Munna (19) S/O Md Imtiaz of Khayrowa Jitpur, PS Chhauradanu Dist Motihari Bihar. A/P Samar Nagar Battola near Netaji Mart PS Pradhannagar Dist Darjeeling. ii) Bijay Sahani (26) @Chhotu S/O Devendra Sahani of Maharaj Colony Ward no 04 PS Siliguri Dist Darjeeling. iii) Dilip Biswakarma (40) S/O It Balaram Biswakarma of Gurung Busty PS Pradhan nagar Dist Darjeeling and 8/9 others to the effect that today on 29/09/2023 at 00:15 hrs received a specific source information that 10/12 miscreants have assembled at Mahananda river bed near Mukta Manch under PS-Pradhan Nagar, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Bhagha Jatin Colony area. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarised the fact in General diary vide Pradhan Nagar PS GDE No 1786 dated 29.09.2023 and as per order I along with SI Goutam Mallik ASI Biplab Kr Das, CV/645 Pankaj Gupta, CV/223 Swapan Chhetri CV/128 Ajoy Kumar Sahani, CV/992 Jagadish Biswas, CV/646 Baban Das, CV/242 Rakesh Monger all of Pradhan Nagar PS, SPC, left for Mahandnda River Bed near Mukta Munch to work out the information in hand. At about 00.45 hrs we arrived at Mukta Munch and as indicated by the source we noticed that 10/12 persons assembled at Mahanda River Bed near Mukta Munch and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 03 (three) of them with deadly weapons in their possession but 08/09 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their associates were assembled there and making preparation for committing dacoity in a house of Bagha Jatin Colony area. On search the above noted weapon of offence recovered from their possession.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Pradhan Nagar PS. The search seizure and arrest made on 29.09.2023 in between 01.15hrs and 02.10 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely i) Md Aslam @ Munna (19) S/O Md Imtiaz of Khayrowa Jitpur, PS Chhauradanu Dist Motihari Bihar. A/P Samar Nagar Battola near Netaji Mart PS Pradhannagar Dist Darjeeling. ii) Bijay Sahani (26) @ Chhotu S/O Devendra Sahani of Maharaj Colony Ward no 04 PS Siliguri Dist Darjeeling. iii) Dilip Biswakarma (40) S/O It Balaram Biswakarma of Gurung Busty PS Pradhan nagar Dist Darjeeling and others 08/09 unknown persons and arrange for its investigation.
