 09 (Nine) bottles of HIT strong Beer each bottle containing 650 ML (Made in Sikkim)

2. 03 (Three) bottles of Royal Blue whiskey each bottle containing 750 ML (Made in Sikkim)

3. 13 (Thirteen) bottles of OLD MONK XXX Rum each bottle containing 750 ML (Made in Sikkim) which was packed in two paper cartoon.

I beg to report that I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Sanjib Biswakarma to the effect that today i.e. 29.09.23 at 18.15 hrs received a source information from Betgara under Bhaktinagar PS that one person namely Sanjib Biswakarma has gathered huge quantity of liquor in his grocery shop at Betgara under Bhaktinagar PS for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1523 dated 29.09.23. As per your kind instruction myself along with SI Rantu Halder, ASI C.P.Adhikary, C/374 Debraj Biswas all of Bhaktinagar PS proceeded to the PO to work out the information. At 18.40 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 19.10 hrs to 20.15 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Sanjib Biswakarma-45yrs s/o Lt Motilal Biswakarma of Betgara, Itavita, PO Salugara, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
