**SUBJ : FIRST INFORMATION REPORT AGAINST THE DRIVER OF A TRUCK
BEARING NO. WB73C1562 AND ITS OWNER**

I, **Arun Kumar Singh**, a practicing Advocate at the District Courts of Darjeeling and Jalpaiguri, and a resident of Indigo Residency, Near Nirmala Convent School, Zila Parishad Road, Pradhan Para, Salugara, P.S. Bhaktinagar, Dist – Jalpaiguri – 734008, am writing to bring to your attention a concerning incident.

On **September 22, 2023, at approximately 9:30 am**, I was driving my car registered under the name of my wife, Sudha Singh, bearing license plate number **WB74W6655**, en route to Jalpaiguri. In the car with me were my son, Adv. Shivam Siddharth, his junior Adv. Pallav Sharma, and intern Aayush Rai. At the Ashighar traffic point, a truck with license plate number **WB73C1562** collided with our vehicle from the rear, resulting in significant damage.

The said truck had been positioned to the right of our car. When the traffic signal turned green, the truck's driver recklessly and carelessly made a left turn, even as we proceeded straight. The collision forced me to swerve left, but due to a toto vehicle on my left and the narrow space available, I had no choice but to apply the brakes. Consequently, a two-wheeler collided with our car from behind.


Following the collision, we confronted the driver of the truck, **WB73C1562**, who then asked the owner of the truck, Umesh Mahato to come to the spot. After a lengthy discussion, Mr. Mahato agreed to cover the repair costs for the damage caused by his truck to our car. He then took us to a nearby garage run by an acquaintance to estimate the repair costs. However, we were dissatisfied with the quality of work at that garage and declined to proceed with repairs there. Mr. Mahato assured us that we were free to choose any garage or service center for repairs, and he would bear the associated expenses. Satisfied with this arrangement, we proceeded to Jalpaiguri for our scheduled hearings.

On the following day, September 23, 2023, we took our car to our chosen service center, Balaji, where we obtained an estimate for the repairs. We promptly informed Mr. Mahato of the repair costs, but he blatantly refused to fulfill his earlier commitment. He adopted a threatening tone, stating that we were free to take any action, including legal recourse, and that he feared no consequences. Despite multiple attempts, he ceased answering our calls.

As a result, when Mr. Mahato stopped responding to my Adv. Shivam Siddharth, contacted him to inquire about his willingness to cover the repair costs. However, Mr. Mahato responded by shouting and issuing threats against my son.

I kindly request your immediate attention to this matter and urge you to take appropriate actions to address this situation promptly
