I, Smit. Sangita Yadav, wife of Sri Aman Pandit, daughter of Shiv Shankar Yadav, a resident of natur para, Jalpaimore, Near Manoj Loha Maat, Ganganagar, Post Office- Siliguri Bazaar, Police Station — Siliguri, and I currently reside at a resided flat at Rajesh Gupta's building situated at Chowrangee More, Patiramjote, PO-Matigara, PS-Matigara, Pin-734010 would like to draw your kind attention to the fact that I am married to Sri Aman Pundit as per Special Marriage Act and after that a social marriage was arranged on 08.06.2015, after that I went to my in-laws house situated at Durga Nagar, ward No. 40 of Siliguri Municipal Corporation, Siliguri, Post Office- Sevoke Road, Police Station- Bhaktinagar pin-734001, where I was subjected to mentally torcher by my mother-in-law namely Smt. Kiran Kumari for not bringing any dowry and due severe torcher by my mother-in-law, my husband took me to Chennai with him in the month of December 2015.

On December, 2016. I returned back to my in-laws house with my husband and to my surprise this time was subject to mental and physical torture by my husband, mother-in-law and my brother-in-law namely Rajnees Kumar and my husband started to force me to give divorce as he stated he was in love with one bar girl namely Ritu and he wanted to marry her and unable to bear the torture, on first week of January, 2017 returned back to my parents' home situated at Ganganagar.

After that my husband used to regularly come to my parents' home and threatened me and started creating pressure upon me for giving divorce and sometimes physically tortured me and from January 2020 my husband torture increased immensely lastly I had to take the help of law and filed a case upon my husband and the said bar girl Ritu on 16.04.2018 before the Siliguri Women Police Station. It is pertinent to mention here that I did not mentioned the name of my in-laws as per the direction of my family members in the said F.I.R.

After that came to learn that my husband left for Pondicherry and in the month of December, 2020 a settlement was made between us in front of society and from January, 2021, I started to reside with my husband at shaktigarh and during the stay I got pregnant and my husband started torturing me physically for aborting the child and during pregnancy my husband torture inhumane act

increased to such an extent that he even did not provide me foods for days and finally the baby died in my womb in ninth month. But my husband behaviour did not change and his torture increased day by day and again on 11.03.2022, I was forced to file a F.I.R.with the NJP Police station against my husband and returned to my parents home and again there was a family settlement and I started to stay with my husband from December, 2022, atC/o Rajesh Gupta, Chowrangee More, Patiramjote, PO-Matigara, Pin-734010.

During stay with my husband again I got pregnant and again my husband started to behave abnormally, torture me and forcefully aborted the child and again third time I got pregnant and this time my husband kicked me in my stomach and due to such act pain started in my stomach and again aborted the child forcefully in August, 2023 and this time my husband stated that he had married Ritu and he had a child namely Samaya Tara and he does want child hence to aborted my child all the times and he further gave me a copy of the birth certificate of the said child and left the home and further stated not to interfere with his personal life.

On 28.09.2023, I came to know that my husband is residing with the said girl at ward number 45, park road, beside Baghajatin high school, baghajotin colony, pradhan nagar, Siliguri, P.S-Pradhan Nagar, pin-734003, and I went there to talk with the said girl namely Ritu. But Ritu and my husband caught hold of me tied my hand and leg and started hitting me with stick and tried to kill me by putting blanket in my face. Later my friend called me and my husband received the call and put the call on speaker and I narrated all the story and my friend immediately informed my brother Ankit Yadav who immediately came and they let me free on condition that I will not take any legal action against them or else they will kill me. At around 1.30pm on the same day of the incident, I went to Siliguri District Hospital situated at court more, Siliguri, pin-734001 for my medical tests and I have attached all the required reports provided to me by the Department of Health & Family Welfare, Government of West Bengal.

Lastly requesting you to save me from my husband, mother-in-law, brother-inlaw and take necessary against my husband, mother-in-law, brother-in-law and the said Ritu, as per law. Thanking You,
