I Mrs Cheten Tashi Sherpa wife of Mr Nihar Mukhia resident of River Dale Farmhouse, Shankar Busty, Saltkasi, Siliguri would like to lodge a complain that at my residence I have been getting harassed and mental tortured from my Father in law Mr Parvin Mukhia and his two female servants named Savitri and her younger sister from Nepal.

Since we moved into this house from Dajeling to Siliguri this year. To be precise lastnight at about 10:30 pm on 1st Oct '23. They tried to barge inside my flat without my consentment and started verbally abusing screamed on top of their voice while my two young daughters were fast asleep. They also disconnected the electricity connection from downstairs. These incidents have occurred multiple times during late hours. I have two children and feel very unsafe due to their actions. Lastnight I informed the Police helpline number over the phone regarding this incident.
