Sir,

I, Sri Dulal Paul, Son of Late Ashutosh Paul, Prop of "Sandhya Battery" residing at B.M. Apartment, Sevoke Road, Siliguri, Ward No: 43 (SMC), P.O. Sevoke Road, P.S. Bhaktinagar, Dist Jalpaiguri do hereby inform you that I have a Godown situated at Baikunthapally, Ward No: 41(SMC), Zilla Parisad Road, P.O. Sevoke Road, P.S. Bhaktinagar, Dist Jalpaiguri. A terrible accident happened yesterday night on 01/10/23. A lot of batteries were stolen from my godown, estimated to be worth of Rs. 26,00,000/- (Rupees Twenty Six Lacks). I don't know who or who committed such a big theft but my godown's neighbours informed me about it tomorrow morning at about 10.00 AM. I am very worried about this horrible incident.

I am highly obliged if you kindly take this matter seriously and urgent basis. I want this matter to be completely investigated and justice given to me.
