Sir,

In producing herewith following articles under proper seizure list- -

- 1] 09 (Nine) bottles of Himalayan Gold 60 UP Country spirit (each bottle containing 600 ml)
- 2] 13 (Thirteen) bottles of OYE OYE 70 UP Country spirit (each bottle containing 300 ml)

I, ASI Dipak Karmakar S/o Lt. Dulal Karmakar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Subal Saha (58 Yrs) S/o Lt. Kaluchand Saha of Don Bosco Colony, P.S- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 03/10/2023 while performing evening patrolling duty, received a source information that one person is selling liquor in his shop situated near Party office, Check Post under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- C/374 Debraj Biswas, C/1426 Prashanta Kumar Dutta had been to near Party office, Check Post under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the shop of the above noted person. But seeing us the above noted accused person could manage to flee away from the spot. I held a raid in his shop in which I recovered the above noted bottles of liquors inside of his shop. I searched for its claimant but nobody came forward and produced any valid document in support of those bottles of liquors. I also examined several local people from whom identity of the owner of the said shop ascertained as mentioned above and also learnt that the above noted bottles of liquors were procured and stored by the above noted accused person illegally and who used to sell it to the local youths since last 03 (Three) months for his illegal gain. Accordingly, I seized the above noted bottles of liquors as alamats under proper seizure list. During local enquiry it came to learn that Subal Saha (58 Yrs) S/o Lt. Kaluchand Saha of Don Bosco Colony, P.S- Bhaktinagar, Dist- Jalpaiguri was running this business in his shop. The search and seizure was made in between 21.40 hrs to 22.15 hrs

I, therefore pray before your good self that a specific case may kindly be initiated against 1. Subal Saha (58 Yrs) S/o Lt. Kaluchand Saha of Don Bosco Colony, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
