Sir,

With due respect I am submitting a written complaint against one accused person namely Pitrush Minj (35) s/o Late Albish Minj of Putinbari, Teastate, PO+PS Matigara, Dist. Darjeeling along with the following seized articles as per proper seizure list:

1. Six (06) Bottles of EMBOSS Fine Whisky each bottle containing 750 ml marked as "Exhibit A" out of which one bottle of EMBOSS Fine Whisky each bottle containing 750ml is taken out as sample and marked as "Exhibit A1".

One (01) Plastic Jar containing five (05) Litres Localmade "Chullu" and marked as "Exhibit-B" out of which one bottle containing one litre taken as sample and marked as "Exhibit B-1".

I, ASI Dhirendra Nath Mondal of Matigara PS would like to lodge a written complaint against the above noted accused person to the effect that today on 05.10.2023 at about 11.10 hrs received a specific source information that the above noted accused person is selling huge quantity of illicit liquor at his house at Putinbari. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 244, Dated 05.10.2023 and informed the fact to the officer-In-Charge, Matigara PS and as per his kind order and direction myself along with C/1053 Paresh Rava, and C/523 Sanjit Kundu, CVF 977 Ganesh Paswan all of Matigara PS left for Putinbari under PS- Matigara to work out the information in hand.

After arrival at Putinbari being identified by the source we held raid at the house of above said person and managed to apprehend him. On being asked he disclosed his identity as noted above and on enquiry he stated that he has been selling illicit liquor at his house without any license for his wrongful gain. Further in presence of witnesses and in presence of the apprehended person I, along with my accompanied team searched his

house and recovered above noted huge amount of illicit liquor from his house.

On demand he failed to produce any valid license/papers for selling and storing illicit liquor in his house. On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under proper seizure list and arrested the above noted person named Pitrush Minj (35) s/o Late Albish Minj of Putinbari, Teastate, PO+PS Matigara, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 05.10.2023 in between 11.35 Hrs to 11.50 Hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Pitrush Minj (35) s/o Late Albish Minj of Putinbari, Teastate, PO+PS Matigara, Dist. Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
