

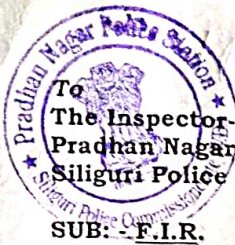

Sir,

In producing herewith one arrested accused person named Biswanath Kumar(24Y/M), S/O. Ram Nihara Mahato of Dagapur near Loknath Mandir, Ps. Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

Twenty bottles (20) of 70 UP Himalayan Fata Fati India made Liquor , each bottle containing 300 ml, each bottle MRP 40, (Total 6 liters) marked as exhibit A (Out of which one bottle has been taken as sample for examination marked as exhibit A1)

I, ASI Manoj Kr. Roy of Pradhan Police Station, SPC would like to lodge this written complaint against one accused person named Biswanath Kumar(24Y/M), S/O. Ram Nihara Mahato of Dagapur near Loknath Mandir, Ps. Pradhannagar, Dist. Darjeeling to the effect that today on 06.10.2023 at 19.15 hrs received a source information that one person has been selling and procuring illegal liquor from his shop styled as Shiba Hotel at Dagapur near Loknath Mandir under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and diarised the matter in General Diary vice Pradhan Nagar PS GDE No 367 dated 06.10.23 and as per his kind direction myself along with CV/128 Ajay Kr. Sahani, CV/223 Swapan Chettri (All of Pradhannagar Ps) had been to Dagapur near Loknath Mandir under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that above noted person has been selling and procuring huge illegal liquor from his house cum shop . Subsequently, I along with my force able to detain the above noted person. On being asked the apprehended person disclosed his name and identity as noted above . Further being searched the above noted seized articles were recovered from his shop which were kept with a cartoon. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Accordingly, I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Biswanath Kumar(24Y/M), S/O. Ram Nihara Mahato of Dagapur near Loknath Mandir, Ps. Pradhannagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19.35 hrs to 20.10 hrs at the spot and arrested him after informing the ground of arrest.


I, therefore pray before your good self that a specific case may kindly be initiated against Biswanath Kumar(24Y/M), S/O. Ram Nihara Mahato of Dagapur near Loknath Mandir, Ps. Pradhannagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
