In producing herewith 01 (one) arrested accused person named (i) Binoy Rai (26 yrs) S/O Dipak Rai of Namchi Bazar, PS- Namchi Bazar, Dist.- South Sikkim, Sikkim under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

(i) 24 (twenty four) bottles of KINGFISHER IMPERIAL STRONG BEER containing 650 ml in each bottle (i.e. total - 15.6 ltrs) and marked as Exhibit "A" and out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "A1".

(ii) 03 (three) bottles of BUDWEISER MAGNUM PREMIUM INTERNATIONAL BEER containing: 650 ml in each bottle (i.e. total - 1.950 ltrs) and marked as Exhibit "B" and out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "B1".

I, SI Goutam Mallik of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted arrested accused person named Binoy Rai (26 yrs) S/O Dipak Rai of Namchi Bazar, PS-Namchi Bazar, Dist.- South Sikkim, Sikkim to the effect that today on 07.10.23 at 22.25 hrs I received a specific source information that the above noted person and the owner of Durga Hotel situated at Siliguri Junction stored huge quantity of illicit liquor at Durga Hotel, Siliguri Junction without any valid paper/license. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS- GDE No 437 dated 07.10.23 and informed the fact to the I/C, Pradhan Nagar PS and as per his kind order and direction myself along with SI Youel Lepcha, CV/992 Jagadish Biswas, CV/645 Pankaj Gupta, CV/223 Swapan Chhetri, CV/646 Baban Das and CV/242 Rakesh Monger all of Pradhan Nagar PS left for Durga Hotel, Siliguri Junction to verify the veracity of the information in hand. After arrival at Siliguri Junction, I held raid at Durga Hotel, Siliguri Junction and managed to apprehended one person who was engaged for selling liquor at the said hotel. On being asked he disclosed his identity as noted above and also disclosed that he along with the owner of the hotel running this illegal business since long for their wrongful gain. On search the above noted illicit liquor recovered from the said hotel. On demand he failed to produce any valid license/papers for selling and storing of such articles at the hotel. On further interrogation he stated that he along with the owner of Durga Hotel are involved in selling and possessing of liquor without any valid license since long for their illegal gain but seeing the police party the owner of the said hotel manage to fled away. Accordingly, I seized and labelled the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and subsequently, arrested the above mentioned detain person named Binoy Rai (26 yrs) S/O Dipak Rai of Namchi Bazar, PS- Namchi Bazar, Dist.- South Sikkim, Sikkim after observing all sorts of formalities at the spot. The whole process of search, seizure and label has been made in between 22.45 to 23.20 hrs.

Under the above noted fact and circumstances I, pray before your good self that specific case may kindly be initiated against the accused persons namely Binoy Rai (26 yrs) S/O Dipak Rai of Namchi Bazar, PS- Namchi Bazar, Dist.- South Sikkim, Sikkim and the owner of Durga Hotel, Siliguri Junction, PS-Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
