I am directed by the Executive Engineer, Mahananda Link Canal Division, 2<sup>nd</sup> mile, Sevoke Road, Siliguri vide his memo no 995 dated 04/10/2023 to report to you that some temporary houses made of tin, bamboo etc have been seen to build up in an unauthorized way on the acquired land of Dy-10 on the left bank at about Chainage 5km of Teesta Mahananda Link Canal (TMLC) of Teesta Barrage Project of Irrigation & Waterways Directorate, Govt of West Bengal, in Mouja Binnaguri, Sheet No 13, Rajganj Block of Dist. Jalpaiguri.

In this connection an application of Md. Barkattulla Saheb addressed to the Executive Engineer, Mahananda Link Canal Division dated 07.09.2023 is enclosed herewith for your further more information about the incident.

So, I am requesting you to kindly take necessary action for vacating the aforesaid land without any future encroachment in the interest of Govt. immediately. This letter along with the enclosures may be treated as General Diary to your end.
