I Sarjina Parvin, Wife of Mustak Islam, resident of Salbari, Sivnagar, P.O. & P.S. Pradhan Nagar, Dist:- Darjeeling, begs to report you the following:-

- That I got married to Mustak Islam, son of Kabul Pradhan in the year 2018 and out of the said wed lock relation we had two issue one boy namely Sakib Islam of 3.5 years and one girl child namely Musfirah Parvin 2 years.
- 2. That after the female girl child was born my husband use to pick up issues without any valid reason and use to quarrel with me whenever he use to return back from home and after few month of giving birth to my girl child he started coming home late night and in a drunken states and use to assault me and my children's and many times tried to kill my female child and soon after few month he started coming home once or twice in a week and whenever I use to ask or my in-laws use to ask about he not coming home he use to get furious and use to abuse me and my in-laws in filthy languages and use to assault me very badly.
- 3. That in the month of January, 2022 I came to know from few of my well wishers and relatives that Mustak Islam (my husband) got married to another girl and has a 2nd wife Namely Rinku Nath and currently staying with her in a flat situated at Salugara, P.S. Bhaktinagar, Dist:- Jalpaiguri.
- 4. That after I came to know about his 2nd marriage I questioned him the same my husband assaulted me and stated to beat me mercilessly with fist and blows and kicks and left the house and since then he is staying with her and not providing any financial help to me for myself or my children's.

- 5. That my in-laws went to my husband and his 2nd wifes house to make him understand but he used abusive language to my in-laws and threw them out of the house and also kept on telling my in-law to throw me and my childres from the house then only he will return home so that he can bring his 2nd wife and stay in the house.
- 6. That on 30/08/2023 my husband and his 2nd wife entered my in-laws house where only I along with my 2 kids were alone in the house and seeing the situation favorable in their condition both of them forcefully pulled me by my hair log and dragged me to the bathroom and made me drink a harpic bathroom cleaner forcefully after which I felt unconscious and then they run away from the house to which my health deteriorated and some how by the gods grace my mother in-law reached home and saw me in an unconscious state and then immediately rushed me to Sukkna hospital and from there the doctor referred me to the medical and this news soon reached to my father and then my father came and took me to Desun Hospital where I was treated and my life got saved but then I did not made any complain against my husband thinking he will change and will return back to me but nothing changed.
- 7. That yesterday i.e 06/10/2023 my husband called my mother in-law over the mobile fone at around 11:42 PM from some other number i.e 8167503393 to which my father in-law received the call and after receiving the call my husband said my father in-law to pick him up from salugara house and then disconnected the call and again called from the same number at 11:44 PM and some other person not known to me said that to take my husband as he is not in a good condition. Soon after that my husband along with his 2nd wife came outside my in-laws house and both were fighting with each other and was abusing me and my children's and was saying that I and my children's have ruined my married life and because of the same he is not being able to stay haply, listening to such shouting and screaming my in-laws and I came out of the house to see whats the matter but as soon as my husband saw me and my children's he became furious started assaulting me and my children's and in the mean time my husbands 2nd wife also supported

him and assaulted me my husband tried to strangulate me and kill me but some how my father in-law save me and his 2nd wife in the mean time tried to kill my daughter of 2 years old by shutting her mouth and nose so that she could not breath seeing this situation and listening to our hue and cry the para people came and saved us and they fled away from there.

I therefore request you to kindly take necessary legal action against my husband and his 2nd wife for the ends of justice.
