- iii. **09 (nine) bottles of Budweiser premium king beer each containing 650 ml total (5.850 liters)** marked as exhibit C and out of which 01 bottle is taken out randomly for examination and marked as Exhibit C-1
- iv. 09 (nine) bottles of Budweiser Magnum Premium International beer each containing 650 ml total 5.850 litrs marked as exhibit D and out of which 01 bottle is taken out randomly for examination and marked as Exhibit D-1

I, ASI Biplab Kumar Das of Pradhan Police Station, SPC would like to lodge this written complaint against one accused person named Tenzing Bhuchung Bhutia (44yrs) S/O Thinlay Bhutia of Tenzing house TN road Sonada, Khasmal, PS Jorebunglow, Dist Darjeeling. A/P Pathargatha NO 1, PS Matigara, Dist. Darjeeling to the effect that today on 09.10.2023 during mobile van duty received a source information that one person has been selling and procuring illegal liquor at his shop which is situated at Salbari, Springdeal Building style as CHO'Z Restro without any valid license. Accordingly I informed the matter to the I/C PS and diarised the matter in General Diary vide Pradhan Nagar PS GDE No 505/23 dated 09/10/2023 and as per his kind direction I along with CV 992 Jagadish Biswas CV/646 Baban Das and CV/242 Rakesh Mangar (All of Pradhannagar Ps) had been to Salbari under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source I found that there were huge gathering and Loud Music was plying. Accordingly, on I recovered above noted 24 (twenty four) bottles of TUBORG Premium beer each containing 650 Ml total (15,600 litrs, 21 (twenty one) bottles of Carlsberg premium elephant strong beer containing 650 ml, total (13.650), 09 (nine) bottles of Budweiser premium king beer each containing each 650 ml total (5.850 liters), 09 (nine) Bottles of Budweiser Magnum Premium International beer each containing 650 ml total 5.850 litres. On being asked he could not produce the valid licence and documents in respect of his recovered articles. Accordingly, I seized the same under proper seizure list and arrested him under Section 41 Cr.PC. The whole process of seizure and label has been made in between 02.25 hrs. to 03.10 hrs.

I, therefore pray before your good self that a specific case may kindly be initiated against named Tenzing Bhuchung Bhutia (44yrs) S/O Thinlay Bhutia of Tenzing house TN road Sonada, Khasmal, PS Jorebunglow, Dist Darjeeling. A/P Pathargatha NO 1, PS Matigara, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
