In producing herewith 01(One) arrested person namely Ajay Das (32 yrs), 8/O- Sanjay Das of Vill- Ganganagar, PO-Siliguri Bazar, PS- Siliguri, Dist-Darjeeling, Paddler of Toto (E-rickshaw), without number plate, Red Colour) along with his Toto under seizer, I SI Ranjit Roy of Jalpaimore Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against him to the effect that, on 09.10.2023 at about 18:45 hrs I along with ASI(AB) 16 Ramjan Ali, ASI(UB)-266 Ranjit Singha and CV-521 Manoj Singha while performing traffic regulation duty at Bardhawan Road, Near Reliance Mart, PS- Siliguri, Dist- Darjeeling found that, the above noted person was plying his Toto (E-rickshaw), as noted above on AH-2 by violating Govt. I, therefore, pray before your kindness that, kindly lodge a specific case in proper section of law against him for violating Govt. order and obstructing for free flow traffic movement and arrange for its proper investigation.
