Respected Sir,

I Shri Pawan Kumar Agarwal, son of late Shiv Bhagwan Agarwal, resident of Prerana Appartment, ward no 26 of S.M.C., near Milan Samity Club, Milanpally, Siliguri, P.O. and P.S. Siliguri, Dist Darjeeling, do hereby lodge this written complaint against my elder brother Shri Ramesh Kumar Agarwal and his wife Smt. Swati Agarwal to the effect stating as follows:-

That in the 2012 my elder brother Ramesh kumar agarwal got married with Smt. Swati Agarwal and started to reside in the same house situated at Prerana Appartment, ward no 26 of S.M.C., near Milan Samity Club, Milanpally, Siliguri, P.O. and P.S. Siliguri, Dist Darjeeling and after some month of their marriage they started creating dispute with me in respect of the house and after creating tremendous pressure upon me to vacate the house but I did not do so as I wanted to stay with my mother and father and also that I am still today unmarried and I was never look after for food by sister in law Smt. Swati Agarwal and it was my mother who took care for me for all things. Thereafter my brother and his wife Smt. Swati Agarwal left the house and shifted to another flat at Kusum apartment, Ward No25, Milanpally.

In the year 2021 my father expired and thereafter my mother Smt. Gaytri Devi went to my eldest brother house namely Pradeep Kumar Agarwal at Chattishgarh and since then I am living separately in my flat which is situated in Prerana apartment. I am doing private job and I go for my job in the morning and return in the evening and as I am unmarried my brother Shri Ramesh Kumar Agarwal and his wife Swati Agarwal have started pressurizing me to vacate the flat and go to some other flat so that both of them can reside in the house without me. I

also like to state that even this flat at Prerana Appartment, ward no 26 of S.M.C., near Milan Samity Club, Milanpally, Siliguri, P.O. and P.S. Siliguri, Dist Darjeeling is in the name of my eldest brother Pradip Kumar Agarwal and he wants me to stay in the flat all alone.

In the month of March 2023 my elder brother Ramesh Kumar Agarwal and his wife Swati Agarwal both of them came to my flat and threatened me that if I do not vacate the flat my sister-in-law Swati Agarwal will implicated me in a false police complaint case and on the same date Swati Agarwal lodged a police complaint before Siliguri Police Station and accordingly I was prosecuted under section 107 Cr.PC. Thereafter I executed bond to keep peace and tranquility and I also submitted a intimation letter to Siliguri Police Commissioner because my sister-in- law Swati Agarwal kept threatening me over phone call asking me that I vacate the flat immediately or else this time she will lodge complaint implicating me in a bigger case.

Accordingly on dated 18/09/2023 at about 8 PM I was standing in front of a Pan Shop near Maharaja Resturant, S.F Road beside S.B.I ATM as I was getting my dinner packed from a hotel then suddenly my brother Ramesh Kumar Agarwal along his wife Swati Agarwal in drunken situation came in front of me and started beating me. My Sister-in-law Swati Agarwal tried to hit me on my head with a stone but I got serious injury in my left eye and also on small area on forehead. Further both of them snatched the collection money amounting to Rs.28500 from my pocket and gold chain and ring. As I started bleeding from forehead as well as eye and I was unable to see anything from left eye and seeing my condition both of them ran away and inconspiracy Swati Agarwal lodged a false complaint against me to save herself as well as her husband Ramesh Kumar Agarwal. On the basis of the written complaint specific case being Siliguri P.S case no. 777/23 under section 341,354 of IPC was started against me and I was arrested in connection with this case and sent to jail custody by Court.

I also state that the IO of the Siliguri P.S. Case No. 777/2023 took me to Sadar Hospital and my eyes and forehead was checked by the available doctor and I required better treatment at specialist eye hospital and the medical report of the doctor is in the knowledge of the

Thereafter I got bail from the Ld. ACJM Court, Siliguri on 27.09.2023 and after coming out from jail I got myself treated at specialized eye doctor as I could not see clearly from my left eye and also the attending doctor advised me not to come out during the day time to avoid suns heat, so as per the advice of the doctor I kept myself inside the room for several days and due to such reason I could not lodge this written FIR at the earliest and there is a delay.

So, I request you to kindly accept this FIR and start specific case against Ramesh Kumar Agarwal and his wife Swati Agarwal and investigate the matter fairly and impartial manner as the witnesses are available near the Pan Shop as well as CC TV footage of the place of incidents will also help the investigating officer to investigate the case.
