## Subject- First Information Report

Respected Sir,

I Santosh kumar Das, S/o- Sri Jagadish Das, resident of Ganga Nagar Road no-1, Near Samaj Kalyan Valmiki Vidyalaya, ward no-05, P.O – Siliguri Bazar, P.S- Siliguri, Dist- Darjeeling, Pin-734005, West Bengal, would like to state as follows:

- 1. That on 11/10/2023 at about 7:00 am I took my daughter namely Nehal das to Heritage Hospital which is at Burdwan Road, Siliguri, for her health check up on complaint of Vomiting.
- 2. That after reaching hospital I went to Emergency ward there one RMO came and asked me about the issue I stated him about my daughter health issue and vomiting, after diagnose RMO came to a conclusion that the condition is not serious but you should admit your daughter for up gradation in health condition of your child.
- 3. That after consulting with my family members I decided to admits my daughter as advised by RMO of the said hospital.
- 4. That the formalities of admission were fulfilled by me and my daughter had been shifted to women general ward along with her mother from Emergency ward for her further treatment.
- 5. That after a nurse came and make saline channel in daughter hand and she left her, when I saw that around 30 minutes had been passed and my daughter is in same condition just a channel was made but no saline water was administer till yet and the same nurse was engage with her mobile, I told her why don't you giving any treatment then she administer a bottle of saline water with the channel of my daughter hand.
- 6. That after few minutes I saw that 2 different injections were loaded with different liquid type of medicine to administer on my daughter, a nurse injected half of the liquid medicine which was loaded in 1(one) injection and left half liquid medicine in the injection and marked that with a paper and the second full injection were kept lying with the medicine desk which was not administered yet.

- 7. That after some time shift of nurses changed and a new nurse came and inject the same remaining one injection to my daughter, as she injected the liquid medicine through injection suddenly health condition of my daughter began to deteriorating and she started squirm. Her mother who was along with her shouted for Doctor and nurses for looking of her daughter.
- That listened her shorting nurses and doctors came and I also went there, a nurse took my daughter and ran towards ICU as the child was not conscious condition and then they started giving CPR to my Child, the process of CPR was started at around 8:00am and after around 9:45am Dr. Subhash Sapkota came and went to ICU and after some time he came and inform me that the child is no more, he also stated me that something wrong is done from our side we will look it into our internal investigation.
- 9. That today i.e 12/10/2023, when I went to Heritage Hospital for taking all documents related to admission, treatment, medicine requisite of my late daughter Nehal Das, the hospital manager totally denying to deliver us same and threatened us for dire consequences, he also stated that he has very high level contacts you law caste people can't do anything to me.
- 10. That from the act and conducts of the hospital doctors, nurses it is very clear cut that due to double dose and medical negligence my daughter has been killed by hospital staffs and doctors.

Sir/Madam, under these compelling circumstances, I am requesting you to take necessary legal action against the said Hospital Staffs and Doctors and do the needful accordingly.
