I Sri Goutam Ghosh @ Bura, Son of Sri Subal Ghosh, resident of Road no.8, Shaktigarh, Ward No.31, Post Office-Siliguri Bazar, Police Station-New Jalpaiguri, District-Jalpaiguri do hereby inform you that yesterday at about 11:00 P.M when I along with my friends namely Md Dablu Son of Late Tafezal Mohammed, Sri Baran Ghosh Son of Late Dhiren Ghosh, Sri Satyajit Ghosh Son of Late Jatu Ghosh and Sri badal Dey Son of Late Manindra Chandra Dey were standing in front of our club i.e. Ujjwal Sangha all of a sudden **Sri Biplab Das @ Tiklu** Son of Late Haripadas Das, **Sri Goutam Roy** Son of Sri Gouranga Roy, **Sri Bicky Verma** Son of Late Satu Verma all resident of Shaktigarh, Ward No.31 of S.M.C, Post Office-Siliguri Bazar, Police Station-New Jalpaiguri, District Darjeeling altogether came tin front of us in an intoxicated condition with iron rods, khukris, bamboo sticks, punchers and started beating me and my friends inhumanly as a result of which Sri Satyajit Ghosh and Sri Badal Dey has been grievously injured and has suffered numerous stiches in their head and are admitted at North Bengal Medical College and Hospital, they also have undergone city scan, chest-x ray and they are battling with their lives in the hospital. They did beat us with an intention to kill us. I also have been injured in my head and have suffered a hematoma. They also have snatched my gold chain weighting about 20 grams. I therefore request your good office to look into that matter and take necessary action against the miscreants.
