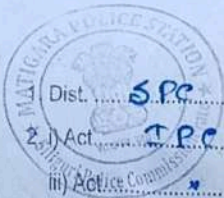

SUB: Complaint against Swadesh Sarkar.

Respected Sir,

With due respect and humble submission, I, Sri Alikanta Singha, Son of Late Lalu Ram Singha, resident of Vill- Kawakhali, P.O.- Sushrutnagar, & P.S.- Matigara, District. Darjeeling would like to inform you as follows:

1. That I, am the absolute owner of a shop room measuring about 14'-0" X 11'-0" (in the back side) and 14'6" X 8'6" (in the front portion) with tin shed having two Rolling Shutters in both back and front side situated at Kawakhali, Medical, P.O. Sushrutnagar, P.S. Matigara, Dist: Darjeeling.
2. That on 11.09.2013, a Tenancy Agreement was executed between Sri Swadesh Sarkar, Son of Late Narayan Chandra Sarkar and me, in respect of tenancy of one semi-pucca shop room and the said tenancy to be effected from 01.10.2013.
3. That since then, Sri Swadesh Sarkar has been enjoying the said shop-room for purpose of running his business on a monthly rental basis for a sum of Rs. 1000/- (Rupees One Thousand) only per month.
4. That as per Tenancy Agreement which was executed on 11.09.2013 it is stated that the second party shall vacate the said shop room on termination of this agreement which has already been terminated on 02.10.2023.
5. That on several requests to the above named tenant, Sri Swadesh Sarkar, to leave the said Shop-Room but he denied to leave and he also threatened me on a regular basis with dire consequences

stating that he will not leave the said shop and also take necessary legal actions against me.

6. That the above named Tenant is also not paying the rent since long and started to occupy the said Shop Room illegally and also said that he will not pay any kind of rent here-in-after.

7. That the Tenant has committed a Criminal Breach of Trust by way of violating the said Agreement and illegally occupying my above noted Shop.

8. That finding no other way I am lodging this complainant before you to take necessary legal actions to evict the said tenant from the said shop room with due process of law.
