I, myself Saraswati Mazumdar aged about-48 years old mother of Sagar Mazumdar S/O Sanjib Majumdar, residing at Word No. 35, Bhaktinagar near Bi ba di Sangha Club, PIN-734007, Siliguri, hereby beg to state that on 10th October, 2023 I came to know from my son Sagar Majumdar that Sucharita Sutradhar, daughter of Late Sukumar Sutradhar has extorted money of around fifty thousand from my son, as they were in a love relationship and she promised to marry him on that assurance and for this one good believe my son gave her fifty thousand rupees on the month of June, 2023 and when she asked for more money to my son and he could not provide that amount she started to threatened my son and She filed a false case against him and threatned to kill him.

At a particular juncture my son is suffering from mental trauma and I am nervous that at any moment my son can do any thing with his life as his mental state is not stable.
