With due respect I the undersigned would like to inform you that I along with Sri Sushanta Biswas (since deceased) had purchased a piece of land measuring about 32 Kathas recorded in R.S. Khatian No. 2844, R.S. Plot No. 366, Mouza – Binnaguri, R.S. Sheet No. 4, Paragana Baikunthapur, P.S. Bhaktinagar now New Jalpaiguri, Dist. Jalpaiguri by virtue of a registered Deed of Sale being instrument no. 1081 for the year of 2013 (Photo copy of the sale deed being no. 1081 of 2013 is annexed herewith).

I would like to further inform you that my name and the name of said Sushanta Biswas have been recorded in the record of right in respect of our equal share being L.R. Khatian No. 1787, 1698, being L.R. Plot No. 366, L.R. Sheet No. 4, Mouza – Binnaguri, P.S. New Jalpaiguri, Dist. Jalpaiguri (Photo copy of Khatians are annexed herewith).

I would like to further inform you that one Smt. Farah Naaz, W/o. Asif Khan of Dinbazar, P.O. Jalpaiguri, P.S. Kotwali, Dist. Jalpaiguri has started to introduce herself as the only daughter of Md. Ajijullah who left a considerable portion of land within the Mouza of Binnaguri and introducing herself as the only legal heir of said Md. Ajijullah, she transferred and sold a considerable portion of land of said Md. Ajijullah to the various buyers against the valuable consideration and she had tried to enter into our registered and self acquired land with the help of one Sakalu Roy who is also known as the land grabber in the locality with an intention to grab the same for their ulterior motive and illegal gain and I was compelled to lodge a written complaint against her and said Sakalu Roy on 12.01.2022 to the O.C. Ambari Out Post under NJP Police Station and on the basis of the said complaint one case has been started being NJP P.S. Case No. 69/2022 dated 12.01.2022 U/S – 188/406/420/120B of I.P.C. (Photo copy of complaint dated 12.01.2022 is annexed herewith).

I would like to further inform you that said Farah Naaz with the help of said Mr. Sakalu Roy have transferred a piece of land measuring about 10 Kathas by virtue of three separate sale deeds being instrument no. 1655 for year of 2022, 1658 for the year of 2022 & 1698 for the year of 2022 to Smt. Arati Bose, Sri Dinesh Gupta & Smt. Usha Devi and Sri Rajen Barman respectively out of our said self acquired land by introducing herself as the owner as she acquired the said land from her said alleged father Ajjullah Mohammad. I could collect some documents from where I found that said Farah Naaz is not the biological daughter of Md. Ajjullah (since deceased) as she claimed before the various authorities including the magistrate, judges and public servant on the various occasions. (Photocopy of the sale deeds no. 1655 / 2022, 1658 / 2022 & 1698 / 2022 are annexed herewith.)

I have collected the marriage certificate of said Farah Naaz which was solemnized on 15.08.2015 at Jama Masjid, Pucca Bazar, Assansol, Dist. Burdwan from where it is crystal clear she is a married woman but she sometimes discloses her as the wife of Asif Khan, S/o. Janab Haji Kamruddin and in the said marriage certificate it is mentioned her father's name Late Saiyed Mahmood of Rahaman Para, Miamoodpur, P.O. Sitarampur, P.S. Kulti, Dist. Burdwan and as per the marriage certificate at present her age is 31 years (photo copy of marriage certificate and its Bengali translation is annexed herewith).

Apart from that I have collected a photocopy of an information of register of births and deaths attested by Executive Officer Jalpaiguri Municipality on 03.09.2019 from where it is found that the name of child is Farah Nanz @ Shamia Parwin and the date of registration of the birth of the child mentioned on 22.08.1986 therein and the father's name of said child mentioned as Md. Azizullah therein and I came to know that said above mentioned reference of birth had / has been using by said Farah Naaz as if it is the true and genuine knowingly well that the said reference is not related with her and may be it has been manufactured purposefully for her ulterior motive and illegal gain and as per the said reference it is found that the present age of the child is 35 years (photo copy of the information dated 03.09.2019 is annexed herewith). I have also collected a sale deed being no.

2418/2021 in which I found that she disclosed that her said alleged father Mohammad Ajijullah is the son of Mohammad Aminullah but said Mohammad Aminullah is the brother of said Mohammad Ajijullah and same has been disclosed only for selling the valuable property to some purchasers against the valuable consideration. (Photocopy of Sale Deed No. 2418/2021 is annexed herewith)

I would like to further inform you that I have also collected a photocopy of Aadhaar card issued by Government of India and in which said Farah Naaz disclosed her father's name as Syed Mahmood of Rahaman Para, Neamatpur, Kulti, Burdwan and she disclosed her date of birth on 22.08.1995 and as per the said Aadhaar Card now she is aged about 26 years (Photo copy of the Aadhaar card is annexed herewith).

I would like to further inform you that said Farah Naaz has furnished the false information to the registering authorities and before the court of law for preparation of three sale deeds in favour of said innocent purchasers against the valuable consideration for her ill motive and presenting those purported documents before the registering authority / public servant for transferring the valuable landed property introducing herself as the daughter of Md. Ajijullah by concealing her actual identity intentionally and knowingly well the said information was / is false and fabricated and her husband, other witnesses in those purported sale deeds, said Sakalu Roy and other persons are also involved in the said commission of offence for their common intention with each and other.

I would like to further inform you that I have filed a suit being T.S. No. 37/2022 against the above mentioned persons and the Ld. Court was pleased to pass an injunction order on 24.01.2022 and said order was time to time was extended by the Ld. Court and same is still enforceable. (Photocopy of the injunction order dated 24.01.2022 is annexed herewith)

I would like to further inform you that during pendency of the above noted suit, the above mentioned persons have intentionally violated the injunction order and ultimately I informed the matter to the Ld. Court and after hearing on 02.09.2023 the Ld. Court was pleased to

direct you to comply the order of the Ld. Court and also further directed to look into the matter for which the court orders will not be violated in any manner causing any serious breach of peace there. (Photocopy of the order dated 02.09.2023 is annexed herewith)

I would like to further inform you that on 30.10.2023 in the morning I found that the above mentioned persons under the instruction and direction of Farah Naaz, her men and persons have started the construction of boundary wall in the western and southern side of my land by accumulating bricks, cement, sand and other materials which are used for the construction of boundary wall and when I made protest against the said act of said Farah Naaz and her associates, she told me that she has already obtained the bail from the court in connection with previous case and she also got the order from the court for construction of boundary wall and building upon my land and she also threatened me by saying that if I will try to disturb her work, she will not hesitate to implicate me in false criminal case regarding molestation and other offences and she also threatened me by saying that she will grab my land at any means and no body can resist her in any manner. (two photographs are annexed herewith for your kind perusal)

Under the above circumstances I would like to request you to investigate the matter and do needful for the ends of justice.
