I, SI Norbu Wangdi Dukpa of Special Task Force, WB, HQ at Siliguri do here by lodge this written complaint to the effect that today i.e. on 02.11.2023 at about 10.20 hrs, I coming by a Tata pick up van bearing Reg. No. WB71B/8748 from Coochbehar District

ing huge quantity of illegal Ganja (Cannabis) and proceeding towards Bihar for its intheir disposal. He further stated that they had already started their journey from Coochbehar and would pass through Siliguri within few hours via Phansidewa More underpass on NH 27.

Hence, there was a strong reason to believe that there is every chance of committing a cognizable offence by the above noted miscreants under NDPS Act and to check the veracity of information, I reduced the information in writing vide Special Task Force West Bengal, HQ at Siliguri GDE No. 06, dated 02.11.2023 and I intimated the information to Shri Sudip Bhattacharjee, Dy. S.P., Special Task Force, West Bengal, HQ at Siliguri accordingly vide STF WB, HQ at Siliguri GDE No- 07 dated-02.11.2023. After obtaining necessary order from him, at about 11.05 hrs, myself, along with a team of Special Task Force, Siliguri consisting of SI Kishun Kerketta, SI Paribesh Chettri, SI Shambik Majumdar, ASI Shuvokar Kundu, C/111 Ekash Oroan, C/80 Pradip Roy and C/133 Pritam Pramanik all of STF, WB, HQ at Siliguri took departure to work on the information, vide C.C. No- 112/23 dated 02.11.2023 from STF WB, HQ at Siliguri Office for Phansidewa More underpass over NH 27 towards Shiv Mandir from Siliguri along with laptop, printer, UPS, weighing machine, Drug Testing Kits and other necessary documents and articles required for Narcotic Drug operations availing Govt. vehicle WB-58AF-9797 and WB24BG/3090 and the same was diarized vide STF, WB, HQ at Siliguri GDE No. 08, dated 02.11.2023

We reached Phansidewa More under over NH 27 at about 11.40 hrs, and met with my source and he briefed me about the detail information and stated that the suspected persons would be arriving the spot anytime. I then looked up for public witnesses to witness the entire process of search and seizure and found one Pulak Barman S/o Sunil Barman of Netaji Subhas Road, Bhaktinagar Sahid Colony, Siliguri (M. Crop), Siliguri PS, Dist. Jalpaiguri and I briefed him about the information we had and requested him to stand as witness. He agreed to be stand as witness during the process of search and seizure and other process thereafter. After that, Myself accompanied by the force and public witness Pulok Barman took an ambush at just ahead of Phansidewa More underpass over NH 27 towards Shiv Mandir from Siliguri.

At about 12.00 hrs, one white coloured Tata Yodha 1700 Pick Up van bearing Reg. No. WB71B/8748 approached towards us which was occupied by two persons at the front seats. My source identified the targeted Pick Up Van bearing Registration No. WB71B/8748 as well as the driver of the said Pick Up van. Accordingly, myself and my WB71B/8748 as well as the driver of the said Pick Up van. Seeing our team and vehicle, team restrained the way of the approaching Pick Up van. Seeing our team and vehicle, both the occupants of the truck jumped from the truck and tried to flee away from there but after a hot chase, we managed to apprehend both the persons.

As per provisions of section 50 of the NDPS Act, 1985 (as amended), I explained both the above noted detained persons that they have legal rights to tender their personal search in front of an Executive Magistrate or a gazetted officer and the same was given to

writing. In reply, he wanted to be searched before an Executive Magistrate or any szetted officer.

Accordingly I sent a requisition to the BDO, Matigara Block, Darjeeling for his presence during search and seizure procedure through a messengers C/133 Pritam Pramanik of STF, WB Siliguri Unit but he returned and informed that the BDO, Matigara Block, Darjeeling was not available today and he could not be contacted. I then brought this information to Shri Sudip Bhattacharaya Dy.SP STF, WB who directed me to contact with Shri Biswasroy Sarkar, Inspector of Police, STF,WB. Accordingly, I then contacted Shri. Biswasroy Sarkar, Inspector of Police, STF, WB and explained him about the information. In return, he told me that he would be arriving at the spot soon.

At about 12.40 Hrs Shri Biswasroy Sarkar, Inspector of Police, STF WB arrived at the spot i.e. ahead NH 27 ahead of Phansidewa More underpass, towards Shiv Mandir from Siliguri where I briefed him the information in a nutshell and introduced him to the detained persons. I Also introduced the witness namely Pulak Barman S/o Sunil Barman of Netaji Subhas Road, Bhaktinagar Sahid Colony, Siliguri (M. Crop), Siliguri PS, Dist. Jalpaiguri to the detained person.

On further interrogation, the detained person confessed in front of the Gazetted officer Shri Biswasroy Sarkar, Inspector of Police, STF, WB that they were in conscious possessions of huge quantity of Ganja (Cannabis) which was kept concealed inside the hidden chamber at backside of the Pick Up van bearing No. WB71B/8748.

Thereafter, Inspector Biswasroy Sarkar intimated the above noted detained persons and also gave a Notice U/S 100 Cr.Pc that, if they wished, they might search every member of the searching team and the vehicles with us before the search of their persons and the Pick Up Van. They then searched the raid team including Inspector Biswasroy Sarkar and me, our vehicles in turn and found nothing with respect to Contraband, except our investigation tools. A Nil Seizure List was prepared duly signed by both the detainees and the witnesses.

Thereafter, in front of the Gazetted officer, Shri Biswasroy Sarkar, Inspector of Police, STF, WB and the independent witness namely Pulak Barman, the detained person namely Pradip Sarkar @ Joy Sarkar and Sudip Das opened the hidden chamber at the backside of the Pick Up Van and unfastened the 02 (Two) numbers of screw and bolts with the help of screw driver and produced 20 numbers of packets in total which were wrapped with brown coloured cello tape. They again opened the hidden Chamber behind the driver seat and produced two similar packets. Then I cut all the packets and took out some portions of Ganjas from each packet and tested them in our Drug detection Kits and found to be positive primarily and again sealed the same with cello tape. I then weighed all the packets individually in our Govt. supplied weighing machine and found in the following quantities:-(1) 6.181 Kgs and marked as Exhibit-A, (2) 6.327 Kgs and marked as Exhibit-B, (3) 6.349 Kgs and marked as Exhibit-C, (4) 6.356 Kgs and marked as Exhibit-D, (5) 6.222 Kgs and marked as Exhibit-E, (6) 6.273 Kgs and marked as Exhibit-F, (7) 6.333 Kgs and marked as Exhibit-G, (8) 6.340 Kgs and marked as Exhibit-H, (9) 6.167 Kgs and marked as Exhibit-I, (10) 6.297 Kgs and marked as Exhibit-J, (11) 6.437 Kgs and marked as Exhibit-K, (12) 6.247 Kgs and marked as Exhibit-L, (13) 6.281 Kgs and marked as Exhibit-M, (14) 6.283 Kgs and marked as Exhibit-N, (15) 6.373 Kgs and marked as Exhibit-O, (16) 6.309 Kgs and marked as Exhibit-P, (17) 6.261 Kgs and marked as Exhibit-Q, (18) 6.234 Kgs and marked as Exhibit-R, (19) 6.291 Kgs and marked as Exhibit-S, (20) 6.234 Kgs and marked as Exhibit-T, (21) 6.300 Kgs and marked as Exhibit-U and (22) 6.196 Kgs and marked as Exhibit-V total weighing 138.291 kgs of Ganja (cannabis) from the hidden chamber of the Pick Up and marked as Exhibit A to Exhibit V. lodge receiv coming On interrogation, both the detainees stated that he had received the contraband arcotic substance like Ganja (Cannabis) from one Taposh Barman of Nishiganj, Coochbehar and were carrying the same to Mujjafarpur, Bihar for its clandestine disposal. Both the detainees further stated that one Ainul Haque and his associates namely Raju Alam and Raja Haque all of Coochbehar are directly involved in this smuggling of Ganja. They arranges vehicles for carrying Ganja. Then, I asked them to produce their valid license/ documents for carrying and possessing of the huge quantity of illegal narcotics contraband articles but they failed to produce any legal paper.

Thus, a reasonable belief having been found that an offence has been committed in contravention of the section 8C r/w 20(b)(ii)(C) of the NDPS Act, 1985 (as amended) and that recovered articles were liable to be confiscated U/S-60 & 61 of the NDPS Act, 1985. Accordingly, I have selzed all the recovered packets filled with Ganja (Cannabis) U/S- 42 of the NDPS Act, 1985 (as amended) under proper seizure list duly prepared by me in presence of witnesses and Shri Biswasroy Sarkar (gazetted officer). I also took signature of the witnesses, accused persons, and Inspector Shri Biswasroy Sarkar as gazetted officer and put my signature as well as seizing officer. Copy of seizure lists were given to the detained person.

Thereafter, all the seized articles have been properly marked and labelled. Took signature of witnesses and accused persons in the labels in presence of the witnesses and Gazetted officer. I then prepared an inventory of all the articles recovered and used during the process of search and seizure of the contrabands.

I then arrested both the above noted accused persons after informing them the ground of their arrest for the possessions and carrying of contraband Narcotic drugs (Ganja) under the NDPS Act and issued arrest memos to them accordingly, duly signed by both the accused persons and witness.

The entire process of Search, seizure, Label, Seal & packing, inventory and arrest were done in between 13.05 hrs and 15.05 hrs.

The entire process of search, seizure, sealed and labelled were done under the supervision of Shri Sudip Bhattacharjee, Dy. SP, STF, WB HQ at Siliguri and videographed the entire procedure of search and seizure through the android mobile phone of C/111 Ekash Oroan of STF, WB Siliguri Unit in compliance to the Order of Hon'ble High Court, Kolkata.

Under the above noted fact and circumstances, a case under sections 20(b)(ii)(C)/25/28/29 of NDPS Act, 1985 may kindly be started against the two accused persons namely (i) Pradip Sarkar @ Joy Sarkar (23yrs) s/o - Sunil Sarkar of Pilkhana , PO-Nilkuthir Babur hat, PS - Kotwali, Dist- Coochbehar, (2) Sudip Das (19 Yrs) S/O - Basu Das of Village - Chakchaka, PO-Nilkuthir Babur Hat, PS-Pundbari, Dist- Coochbehar, (3) Taposh Barman of Nishiganj, Makpala, Dist. Coochbehar, (4) Ainul Haque of Sutkabari, Coochbehar, (5) Raju Alam of Sutkabari, Coochbehar, (6) Raja Haque of Coochbehar and (7) owner the Pick Up Van bearing Registration No-WB71B/8748 and arrange for its proper investigation.

Family members of both the arrested accused persons have been informed regarding the arrest of Pradip Sarkar @ Joy Sarkar and Sudip Das over phone and Whatsapp Messages.

Superiors of STF, WB have been apprised of the seizure, arrest and other proceedings made so far in this regard.
