One paper made cartoon containing 30 packets of fire crackers styled as "ELECTRIC CRACKERS ORIGINAL" Mfg by Pooja Fireworks, Sivakasi, total weight 69 Kg

(iii) One paper made cartoon containing 29 packets of fire crackers styled as "KING KOBRA" Mgf by Lakshmi Sri Fireworks, Sivakasi, total weight 61 Kg.

(iv) One paper made cartoon containing 33 packets of fire crackers styled as SUPER POWER 1K", Total weight 23 Kg.

(v) One paper made cartoon containing 22 packets of fire crackers styled as "KING KORBA ELECTRIC CRACKERS" Mfg by Lakshmi Sri Fireworks Factory, Sivakasi, Total weight 47.350 Kg.

(vi) One paper made cartoon containing 300 packets of sound fire crackers styled as "DULALER CHOCOLATE ELECTRIC SOUND" total weight 20.400 Kg.

(vii) One paper made cartoon containing 300 packets of sound fire crackers styled as "DULALER CHOCOLATE ELECTRIC SOUND" total weight 29.900 Kg.

(viii) One paper made cartoon containing 96 packets of sound fire crackers styled as "ELECTRIC CRACKERS ORIGINAL" Mfg by Pooja Fireworks, Sibakashi, total weight 37.100 kg.

(ix) One big sized nylon bag containing 270 packets of sound fire crackers styled as "BISHAL CHOCOLATE" Mfg by Bishal Industries total weight 23.200 kgs

I SI Goutam Mallik of Pradhan Nagar PS do hereby lodged this written complaint against (i) Bikash Saha and (ii) Abhay Saha both of Narmada Bagan, Road No -01, near Satsangha, Ward No-46, PO-Champasari, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 08.11.23 at 13.30 hrs I received a specific source information that one Bikash Saha and Abhay Saha both of Narmada Bagan stored huge quantity of illegal fire crackers at their residence with a view to sale the same in high rate to their design customers for their illegal gain. Accordingly, diarized the fact in General diary vide Pradhan Nagar PS GDE No 463 dated 08.11.23 and informed the fact to you and as per your kind order and direction myself along with SI Youle Lepcha, ASI Biplab Das, ASI Monaj Kr Roy, C/762 Majibul Islam, CV/645 Pankaj Gupta, CV/223 Swapan Chhetri, CV/646 Babon Das and CV/128 Ajoy Kr Sahani left for Narmada Bagan to verify the veracity of the information in hand. At around 13.55 hrs we arrived at Narmada Bagan, Road No -01, near Satsangha, Ward No-46, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and being identified by the source, I held raid in a residence situated at Narmada Bagan, Road No -01, near Satsangha, Ward No-46, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling but seeing the police party aforesaid persons managed to fled away from their residence. Accordingly, I contact with the local people of that area and in presence of the witnesses I entered in a room being identified by the source and found total 08 (eight) numbers of paper made cartoon and 01 (one) big nylon bag kept in the said room. On search in presence of the witnesses the above noted fire crackers found inside the said paper made cartoon and nylon bag without any safety measure and without any permission from appropriate authorities and if any accident taken place due to negligent act of the accused persons who stored the said illegal fire crackers, that may cause huge loss of life and property of the area. During raid nobody could turn up before me to claim the said fire illegal fire crackers as their own but on further enquiry it could be learnt that one (i) Bikash Saha and (ii) Abhay Saha both of Narmada Bagan, Road No -01, near Satsangha, Ward No-46, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling stored the said illegal fire crackers at their residence without any precautionary and safety measure and without any permission from appropriate authorities. Accordingly, I seized the above noted illegal fire crackers under proper seizure list in presence of the witnesses . The searched and seizure made in between 15.15 hrs to 19.05 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the accused namely (i) Bikash Saha and (ii) Abhay Saha both of Narmada Bagan, Road No -01, near Satsangha, Ward No-46, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and arrange for its investigation.
