Subject:- Regarding threat of death by Bapi Srivastava and Vikas and his associates for not taking up the case.

Respected Sir,

It is a request to inform that we had registered a case against Bapi Srivastava in the local Bhakti Nagar police station on date 08/11/2023. The next day after registering the case, Bapi Srivastava's parents and his friend Vikas, a boy named Vikas, came to our house and started talking about taking up the case. We told these people in front of our family that Bapi Srivastava and his friends are coming to our house. Abusing and vandalizing the gate of the house was not good, on hearing Vikas started threatening us that take up the case otherwise the child of your house will be taken away and we will see you anywhere, from our house. Children study in Milton School, Gandhinagar ward no 43. We fear that any incident may happen to the children of our house through Bapi Srivastava and his associates.
