Sir,

In producing herewith one arrested accused person namely Mithun Mandal-30yrs s/o Mohitosh Mandal of Khola chand Fapri, PO Baikunthapur PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- (1) 35 packets of King Cobra electric crackers each packet containing 28 pieces
- (2) 18 packets of Black cat chocolate crackers each packet containing 10 pcs [SL 1 & 2 =Total-07 Kgs]

I beg to report that I, PSI Koushik Raha s/o Jitendar Raha of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted arrested accused person to the effect that on 11.11.23 at about 20.05hrs received secret source information from Kholachand Fapri that one person stored and selling huge quantity of band fire crackers at Kholachand Fapri under Bhaktinagar PS. Diarized the information in GD vide Bhaktinagar PS GDE no-525 dated 11.11.23 and as per your kind instruction myself along with SI Rantu Halder, PSI Chiranjit Saha, ASI Chandra Prakash Adhikary, C/374 Debraj Biswas, CVF/619 Dharmendra Roy left for Kholachand Fapri, Seventy More to work out the information.

At about 20.35 hrs we reached at Kholachand Fapri, sometimes after, being identified by the source our police party held raid in the shop of above noted person and recovered the above noted articles from his shop. On demand he could not produce any valid documents/license in support of said fire crackers and also stated that he was selling the band fire crackers in his shop without any valid documents or license violating the provision of law which may endanger human life and likely to cause hurt or injury human or property. Accordingly I seized the above noted fire crackers in presence of witness duly signed by him from the possession of Mithun Mandal -30yrs s/o Mohitosh Mandal of Khola chand Fapri, PO Baikunthapur PS Bhaktinagar Dist Jalpaiguri and arrested them u/s 41 Cr.pc. (The seizure was made in between 20.45 hrs to 21.15hrs)

I therefore request you a specific case may kindly be started against the accused person namely Mithun Mandal -30yrs s/o Mohitosh Mandal of Khola chand Fapri, PO Baikunthapur PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for its investigation.
