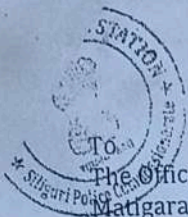

Sir,

In producing herewith arrested accused person named Upen Singha (72), s/o - Late Sarua Singha, of - Vivekanandapally, Kadamtala, PS - Matigara, Dist - Darjeeling along with copy of memo of arrest, seizure list and seized articles viz 12 (Twelve) Sealed Himalayan Gold 60 Up Bottles Country Spirit each containing 600 ml @ Rs. 130/- each totaling amount of Rs. 1560/- marked as exhibit "A" and one bottle taken as sample.

The fact of the case is that today on 10.11.2023 at 20.45 hrs received source information that one Upen Singha (72), s/o - Late Sarua Singha, of - Vivekanandapally, Kadamtala, PS - Matigara, Dist - Darjeeling have stored huge quantity of I.D liquor at his shop at Kadamtala illegally for sale to the People for his wrongful gain.

I informed the matter to O/C NBMC OP and as per his direction I along ASI Amal Roy, C/252 Tarun Mandal, CV-638 Partha Biswas left for Kadamtala to work out the information. At about 21.05 hrs held raid at the shop of Upen Singha (72), s/o - Late Sarua Singha, of - Vivekanandapally, Kadamtala, PS - Matigara, Dist - Darjeeling and on search 12 (Twelve) Sealed Himalayan Gold 60 Up Bottles Country Spirit each containing 600 ml @ Rs. 130/- each totaling amount of Rs. 1560/- have been recovered. On demand he could not produce any documents / License for possession such quantity of I.D liquor. On interrogation he admitted that he stored the said I.D liquor illegally for sale to the interested persons for his wrongful gain.

So, I seized the said 12 (Twelve) Sealed Himalayan Gold 60 Up Bottles Country Spirit each containing 600 ml @ Rs. 130/- each totaling amount of Rs. 1560/- in presence of witnesses under proper seizure memo and arrested him U/S 41 Cr.P.C. The search seizure and arrest was made in between 21.25 hrs and 21.40 hrs.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Upen Singha (72), s/o - Late Sarua Singha, of - Vivekanandapally, Kadamtala, PS - Matigara, Dist - Darjeeling and kindly arranged for its investigation.
