Subject: Complaint against Domestic Violence.

Sir,

I, Mrs. Yojana Rai, Wife of Mr. Peter Rai, aged about 40 years old, resident of Sisabari, P.O. New Rangia, P.S. Matigara, District - Darjeeling, Pin - 734011; would like to intimate you about the following facts:

That I am the legally wedded wife of Mr. Peter Rai, Son of Simon Rai; and our said marriage solemnized on the 16th February, 2009.

That after our said marriage, from the year 2009 to 2012, I was staying with my said husband at Assam, which was the place of his service then. But, soon after few months passed from the date of our said marriage, I was subjected to cruelty and torture, further I was also harassed physically as well as mentally by my said husband (namely Mr. Peter Rai). Further, corresponding to the same, I had numerous times, verbally complained about his said cruelty against me, to his superior at his place of work then.

That in the year 2012, he retired from his service and in the year 2013, he joined another service at DSC; further, since the year 2013, my said husband and I had been residing together at my above said residence mostly and also sometimes, at our another house, at Singmari, Darjeeling. But still his atrocities and cruelty against me had not stopped; and due to his threatening of dire consequences, I was forcefully made to keep my mouth shut against such cruelty upon me by my said husband.

That during the service vacations of my said husband, he used to come home intoxicated daily; and used to assault and abuse me mercilessly. Further, after bearing such daily harassment, assault and cruelty by my said husband, I was pushed into depression and was numerous times instigated by said husband to end my life by committing suicide.

That on 29.10.2023, at around 08:30 a.m.; my said husband came home in a drunken state and started to throw big stones at the windows of the house, which resulted in the damage of the property. Further, when I tried to stop him, he picked up a spade (metal) and tried to hit me with it. I however, saved myself from his attack and locked myself up in the house screaming for help. Due to my loud shouts and cries of help, he ran away from the incident spot.

That after few days of such above mentioned incident, I decided to forgive my said husband and accordingly I went to our another said house, at Singmari, to settle the dispute between us and stay together as husband and wife. But soon the next following day, I was again subjected to physical and mental torture, assault and cruelty by my said husband.

That on 08.11.2023, at around 11:00 p.m.; my husband came to our said another house in an intoxicated condition, and started to hit me with bare hand and a stick, further, he even tried to choke me to death. But somehow, I cried for help, and managed to save my life. Then, he grabbed me by my hair and dragged me out of our said another house. I even pleaded before my said husband to let me stay but he did not allow.

That somehow, being helpless and all alone at such time of the night, the neighbours came to my rescue and gave me shelter at their home that night, thereafter, with the help of them, I managed to return back to our said house at Sisabari, the next day.

Therefore, till this date, I am being continuously threatened by my said husband with dire consequences. Further, I beg you to kindly do the needful and save me from

the cruelty and torture done by my husband and also protect me from mental as well as physical harassment from my said husband.

That I fear that, my said husband shall again create some nuisance and try to physically harm me. Such action(s) has led me into difficulties in managing daily chores of my life and also causes me mental pain and agony.

Therefore, I beg you to kindly do the needful and take appropriate action(s) against my said husband and safeguard me from his atrocities, for the ends of justice.

[Note: That due to constant threatening and harassment by my said husband, I was unstable and unable to gather courage to lodge a complaint against my said husband. Therefore, I request your kind office, to kindly consider the delay in filing this said complaint and may this be treated as the F.I.R. copy.]
