In producing herewith one accused person namely Ashim Barman-39yrs s/o Lt Sukh Chand Barman of Bedgara, Near Primary school, PO Salugara, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

- 1. 24 (Twenty four) bottles of TUBORG strong Beer each bottle containing 650ML
- 2. 07 (Seven) bottles of MacDowell no-1 Luxury premium whiskey each bottle containing 180 ML
- 3. 06 (six) bottles of officer's choice Grand whiskey each bottle containing 180 ML
- 4. 02 (Two) bottles of Mac Dowel No-1 Luxury whiskey each bottle containing 750 ML which was packed in two paper cartoon.

I beg to report that I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Ashim Barman-39yrs s/o Lt Sukh Chand Barman of Bedgara, Near Primary school, PO Salugara, PS Bhaktinagar Dist Jalpaiguri to the effect that on 19.11.23 at 14.15 hrs received a source information from Bedgara under Bhaktinagar PS that one person namely Ashim Barman has gathered huge quantity of liquor in his grocery shop at Bedgara for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-892- dated 19.11.23. As per your kind instruction myself along with SI Rantu Halder, PSI Koushik Raha, ASI/915 Chandra Prakash Adhikary, Const/374 Debraj Biswas, proceeded to the PO to work out the information. At 14.45 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 15.05hrs to 16.10 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Ashim Barman-39yrs s/o Lt Sukh Chand Barman of Bedgara, Near Primary school, PO Salugara, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
