Today When My Elder Brother went to bank for withdrawing money on that time he saw Rs. 25,000.00 was debited from our Joint account no. 50190036558353. He told me the incident. Then I went to the Bank for collecting account statement of all account and I saw that My FD with my daughter having account number 50180028355676 was broken and credited to myself account number 50180005840258 of Rs. 2,48,856. On dated 19.11.2023. On same date there was 8 transaction in my savings account number 50180005840258 and debited Rs. 2,47,963.00 from my said account. On today dated 22.11.2023 Rs. 25,000.00 also debited from my joint account with my elder brother 50190036558353.00 , Another transaction of Rs. 59734.97 was debited from our joint FD account with my daughter on date 20.11.2023 and credited to my savings account 50180005840258 without my concern and after that on same date RS. 60,000.00 debited from my said savings account.
