Respected Sir,

I Sri Noni Gopal Roy, an ex-service man of Military Engineering Service residence of Ward No 23, Post Rabindra Sarani, Dist Darjeeling, Pin 734006, (Ph No 9832371731), would like to state that Mrs SANDHYA RANI DEY, Mrs TULU DEY, W/o Mr Amal Dey along with her Sister In Law and other family members has jointly humiliated us publicly causing intense mental and physical harassment and defamation.

Sir, I would like to explain, that on 19th April, 2022 my son Sri Ranadeep Roy, purchased a plot from Sanchit Dey and his family in order to use it as garage cum store room measuring 288 sq.ft. which is abut to the house of Mrs Sandhya Rani Dey in the North Side. He constructed a temporary structure there upon at the very same time i.e. June 2022. Since then there was no issues what so ever.

Sir, in the month of June, 2023 my son Sri Ranadeep Roy who is a banker by profession got promoted and transferred to the state of Odisha. Being a senior citizen, myself and my spouse Smt Sunita Roy (suffering from Hypertension, Diabeties Type 3 under going regular medical ailment) was totally depended upon him.

Now taking the opportunity of this Mr Amal Dey, so called my neighbor gave complaint against the structure somewhere during the month of August, 2023 (after almost 1 year.) stating that there home is getting ruined due to it.

Sir, after knowing the about the complaint and as per instruction received from the Ward Councilor and Borough Officer, I was doing the necessary alteration in the structure through labors. But suddenly, in the morning Mrs Tulu Dey alongwith Mrs Sandhya Rani Dey, came infront of the structure and started shouting at us using all sorts of rubbish slang languages which a standard citizen might not even dream upon. Mrs TULU Dey, W/o Amai Dey, did not even hesitated to take all the tools from the labours in order to stop them and follow her instruction to demolish the entire structure. All the alteration of the structure

was being conducted because of their complain, but still throughout the day they humiliated us combinedly in every way possible. (their photograph is attached)

Sir in order to defend me, when my spouse Smt Sunita Roy went out, they including their entire family members (particularly the female members) jointly threatened us, that they will use false allegation against us (such as attempt to rape, touching them in inappropriate ways and etc) and get us arrested.

Sir, they have publicly used words, such as rapist, smuggler, thieve, a professional thief, having illegal relation with tenants causing them pregnancy and many such other languages which I can't even speak about, open in the road in front of every onlookers.

Sir, they have also threatened us that if we don't demolish the structure entirely, than they will through stones and fire sticks during night at our home and burn us alive.

Sir, because of this I myself and my spouse is feeling extremely traumatic, frightened, unsafe and heavily defamed. Being an elderly senior citizen and a hypertension suffering patient it is not even possible for us alone to protect our self from them. Hence I myself and along with my suffering spouse Smt Sunita Roy, am praying before you for apathetic justice and help.
