Sir,

I, Smt. Banashree Bhattacharjee, Advocate at Siliguri Court, residing at Lake Town, Siliguri, District- Jalpaiguri, do hereby lodge this F.I.R against some members of "Tiger Sporting Club", Bharat Nagar, Siliguri and others for the incident stated below:

That on 15.11.2022 at 9:45 pm (Friday), I along with my husband was going from Lake Town to Rabindra Nagar for some personal works and as I am pregnant, also had a plan for going to G.B. Das Nursing Home for purchasing important medicines for myself. After crossing the Fulleswari Bridge we turned left and found the road blocked by bamboo. Thereafter we took most left and took right from there and saw the same, that road was also closed by same Puja pandal. After that we returned at the same road we tried to take before and crossed the bamboo this time. In front of the puja pandal of "Tiger Sporting Club", we asked one member of club authority about reason behind blocking empty road, it was very important channel road and due to such obstruction public were suffering. We asked them to send volunteer if required instead of blocking the road permanently. From the very beginning that person was aggressively claiming that they had permission and have right to close the road, no one have authority to ask them. Then I asked to show the permission, because the road was totally empty, hardly one-two motor vehicles were running, there was no need for such barrier at that time. He started shouting and 509/109/34 IPC using filthy languages towards us. Further some members from the club came SI Haren Kr. and also started unlanguages. When I was trying to capture their behavior.

Mohanta has members from club/people in that colony came there and without knowing the reason they started to beat my husband very badly and captured our videos. It is necessary to mention here that two ladies came first and tried to snatch and the investigation, and also started threatening us with dire consequences and using abusive

extort my mobile phone, when I was trying to save my phone, they hit on my hand again and again, after that even few male person also did the same with me for snatching my phone. No club members and no persons from that colony came to save us, moreover 30 to 35 people chased us and beat my husband with fists and blows, and also punched on various part of his body. Even after saying that I am pregnant no males and females present there considered our situation. Moreover they continuously tortured me and my husband mentally by using abusive and unspeakable languages and physically beating my husband with fist, blow, punch, slap, lathi etc and touching my body and also threatening us with dire consequences. They confined us like a chor and also tied up our Scotty with roshi near pujo mondop, and also wrongfully restraint us, so that we could not run away from there. Lastly one club member Mr. Anutosh Sarkar along with two other members came and rescued us from that place.

In the above shameful incident from the club members of Tiger Spotting Club, I would like to state you that I am an Advocate of Siliguri Court and my husband is working in a reputed company. We belong to educated family and we have a good reputation in the society. By this kind of illegal act we are suffering from huge mental agony and also financial losses. Not only physically but also they have injured our reputation. It is necessary to mention here that if any club organizes Kali Pujo, it means they take big responsibility of all the people who pass over from there. By this type of act it is clear that some members of the club are not have that much ability, education and the quality to taking responsibility of people. It is very dangerous to give responsibility to such kind of irresponsible, inhuman, cruel, heartless people to handle and take care of people.

It is necessary to mention here that the above incident is simply called Criminal Offence and is not simply ignorable anymore. As I am pregnant women and anything would have happened to me. Further we also had a small puppy with us at that time, she could also be injured or died by such kind of dangerous activities.

Under the above mentioned acts of such people, it is crystal clear that some members of said club jointly abetted the commission of offence and also did criminal conspiracy against us. Not only that by showing criminal force they deprived us from the enjoyment of a right of way and also tried to extort our

mobile phone from our possession. Such unlawful assembly continuously used threatened us by saying injured our reputation in public and insulted us and gave provocation with intention to break the public peace.

In these circumstances I am requesting you kindly take up the matter and register as a criminal case against the accused persons as per provisions of Criminal Law as they are dangerous in nature and character and collect the names of accused persons from club member Mr. Anutosh Sarkar, and also take necessary action against them ASAP.
